Dear Ms. Beaudry:

Please find enclosed, protest petitions signed by individuals who have ownership or agency status concerning properties located within 100 feet of the boundary of the Heritage Row planned unit development rezoning proposal, which is on City Council's published agenda for this evening.

These signed petitions represent 16 out of the 26 qualified parcels. By our calculations, this is over 51% of the land area within the 100-foot radius (minus publicly-owned land). While perhaps not relevant to Heritage Row, we note that this represents more than double the 24% represented by the protest petition against City Place, the previous incarnation of this PUD that was unanimously rejected by City Council on January 5, 2009.

Per City ordinance, a protest petition, filed at or before the public hearing for a zoning amendment, and representing 20% or more of the land area located within a 100-foot radius of the proposed rezoning boundary, shall result in eight affirmative votes by City Council being required to approve the rezoning.

Please confirm that we have complied with the provisions of this ordinance in full, and that the eight affirmative vote requirement will be included on the agenda and imposed for the Heritage Row rezoning vote.




