Mayor Hieftje called the meeting to order at 7:08 p.m. in the Guy C. Larcom Jr., Municipal Building, 2nd Floor Council Chambers, 100 N. Fifth Avenue.

1. Tim Hull - Appointments (E-1)

Tim Hull, 1412 McIntyre, addressed Council regarding the need for adequate citizen representation on the Ann Arbor Transportation Authority Board. He said that there is no available contact information for any of the existing AATA Board members on the AATA website or the City's website. He suggested that all boards and commissions be required to make public contact information for their members.

2. Thomas Partridge - Affordable Housing (DS-11)

Thomas Partridge, 4220 Eyrie Dr., addressed Council regarding affordable housing. He said that there is a need for representation at the state level and a need to work cooperatively to protect those Americans that are most vulnerable in this economy.

3. Kathy Griswald - Traffic Calming (CA-4)

Kathy Griswald, 3565 Fox Hunt, addressed Council regarding traffic calming. She said that she supports traffic calming and that the most cost effective action a municipality can take to improve traffic safety is improving sight distance at intersections by cutting down vegetation in the right-of-way of streets.

4. Blaine Coleman - Boycott Israel

Blaine Coleman, P.O. Box 7038, addressed Council regarding boycotting Israel and asked Council to vote on a resolution boycotting all products from Israel.

5. Mozhagan Savabieasafahni - Boycott Israel

Mozhagan Savabieasafahni, P.O. Box 7038, addressed Council regarding boycotting Israel.

6. Kim Lemasters - Ban on Upholstered Furniture on Porches

Kim Lemasters, 434 Cambridge in Dexter, Michigan, addressed Council regarding support for an ordinance to ban upholstered furniture on porches, noting that her son was killed in a fire caused by a couch fire on a porch. She asked if such an ordinance is being drafted and if so, how long it would take to get a draft of the ordinance to Council for consideration.

7. Alan Haber - The Commons

Alan Haber, 531 Third St., addressed Council regarding the library lot. He said that the lot should be considered as a commons for the people of Ann Arbor.

8. Tarik Green - Census Non-Response Follow Up

Tarik Green, 8120 E. Jefferson, Detroit Michigan, representative of the US Census Bureau, updated Council and citizens on what is currently happening with the census efforts. Mr. Green asked everyone in the community who has not completed the form to cooperate with the census takers when they come to their door to gather census information.

9. Mae Keller - Stormwater Drainage Issues

Mae Keller, 498 Village Oaks Ct., addressed Council on behalf of the Village Oaks Court residents regarding the impact to them because of the City's management of stormwater in this area. Ms. Keller stated she believes that recent flooding problems were the outcome of a poorly designed stormwater plan in their neighborhood that has been brought to the attention of city engineers repeatedly over more than 12 years. Ms. Keller is willing to work with the City regarding this issue.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

RAIN FALL LAST WEEKEND

Acting City Administrator Sue McCormick said that the rainfall during the last weekend's storm was 2.7 inches. The heaviest of which fell just after midnight on Saturday, where an inch fell in a half hour, she said. Staff worked over the weekend responding to calls relating to the storm. As of approximately 4 p.m. this afternoon, the City had received 42 calls, primarily from residents who had water either on their property or in their basements. Each complaint is being investigated by staff. Follow-up investigations are difficult after the event has occurred, but they will do their best to find the sources of the problems and as they are able to, assist citizens with trying to resolve these issues.

Ms. McCormick noted that there a few downed trees as a result of the storm and staff worked to remove debris from the roads on Sunday. There are a lot of gravel roads affected within the city limits and all are suffering some degree of erosion. Crews started fixing the worst of those issues on Sunday.

Ms. McCormick encouraged the public that if they have had a situation that they have not reported, to let the City know for their data gathering purposes, and also in case the City is able to respond and assist in some way.

LED STREET LIGHT PROGRAM

The LED Street Light Program in Ann Arbor was chosen to represent the U.S. in the International Energy Globe Awards and was one of only three international finalists in their category. The ceremony was held in conjunction with the World Environmental Day on June 5, 2010.

ANN ARBOR CONNECTOR STUDY

An informational meeting has been scheduled for June 8, 2010 regarding the Ann Arbor Connector Study, to look at signature transit and corridors for public transportation options. The meeting is scheduled to begin at 6:30 p.m. at the Downtown Branch of the Ann Arbor Public Library and would include a presentation in open-house format. Ms. McCormick encouraged members of the public who are interested in public transportation to attend that event.

UPDATE ON POLICE/COURT BUILDING

Ms. McCormick updated Council regarding the status of the interior and exterior construction work on the new Police and Court building.

Within the existing Larcom building, the foundation work for the new elevators is being completed and the structural steel for the elevator tower is nearly complete.

VETERANS MEMORIAL ICE ARENA

The Veterans Memorial Ice Arena received two national awards from Ice Skating Institute (ISI). They are the leading national ice industry trade association for ice skating facilities and individual skaters with over 600 facility members and 55,000 individual members. The Adult Hockey Program at Veterans Memorial Ice Arena was named Adult Hockey Program of The Year and Jeremy Lewis was named Lead Director of the year.

ANN ARBOR PARKS

Warm weather over the Memorial Day weekend meant the city parks were busy. The outdoor pools welcomed approximately 4000 visitors over the three-day weekend, and over 1150 people rented boats at the canoe liveries and 45 special events were booked in the parks with 1500 visitors.
