*The addresses in the “initial mailing” include property addresses and owner addresses. If RPP District approved by Council, only the first mailing advising of the new parking district would include the owners as owners could change at any time. Subsequent annual mailings will be sent only to program-eligible property addresses in the district which will remain constant. NOTE: Mailings to reach targeted audience ~mid-August during student move-in so mailings are received by new tenants with leases for fall semester and avoids tenants whose lease expires end of July. This also results in Customer Service permit sales in August rather than July tax season. Discussions are for permits to be valid August 15 through August 14 of each year to cover beginning of most rental agreement timeframes.

Streets Included in Request:

1. E Ann St, N Division St to Glen Ave
2. Catherine St, N Fifth Av to N Ingalls St
3. N Division St, E Huron St to High St
4. Elizabeth St, E Kingsley St to High St (west side only)
5. High St, N Division St to N State St
6. E Huron St, N Division St to N Ingalls St (north side only)
7. N Ingalls St, E Huron St to E Kingsley St
8. E Kingsley St, N Division St to N Ingalls St
9. Lawrence St, N Division St to N Ingalls St
10. N State St, E Huron St to High St (excludes west side Kingsley to High, St Thomas Church)
11. N Thayer St, E Huron St to E Kingsley St

Notes:

328 & 334 Catherine, and the 200 & 300 Blocks on the west side of N Ingalls are zoned as “O” (office, not residential). The portion of the streets adjacent to these properties will not be included in the RPP District.

Due to St Thomas Church & current 1-hour M-F 8-6 parking restriction, the east side of Elizabeth St and the west side of N State Street (E Kingsley to High) are excluded.

There will be two different maps. Streets with existing restrictions such as “no parking” will remain the same. The Traffic Control Order will show streets to be signed for residential parking. The Residential Parking Permit District map will show the streets & addresses eligible to participate in the program (purchase a permit once requirements are met). 6/18/2010

Old 4th Ward Highlights:

- Initial Mailing to Properties & Owners (approximately 570 addresses total)
- Annual Mailing to Eligible Properties (approx 333)
- Mailing to be sent early-August to avoid summer tenants & capture new renters for fall move-in (avoids July tax season rush for Customer Service)
- This RPP District includes 76.5 block-face properties eligible to participate
- This RPP District includes 50.5 block-faces signed for RPP District parking
- This RPP District includes ~26 Home-Owner Occupied Addresses
- The cost for this RPP District Set-Up is \$20,985.00
- Permits, as approved by City Council cost \$50/year/permit & first permit must be “fixed”
- The 12-month calendar for this RPP District is August 15 through August 14 of the following year
- This District is considered adjacent to Central UofM Campus and those rules apply (ie limit 5 permits with 1st fixed & up to 4 transfer permits/year)
- Areas zoned other than “residential” are not included in the district nor eligible to participate
- We require 6-8 weeks to set-up new district (mailing, sign installation, permit ordering & sales)
