**Consent Agenda.** There are (28) items on the consent agenda.

**Public Hearings.** There are four (4) public hearings which are listed below and under second readings.

- Public Hearing and Resolution to Approve Valhalla Ann Arbor Site Plan and Development Agreement, 31, 50, 57, 77, 97, 98, 107, 145, 147, 151, 155, 159, 163 Valhalla Drive and 2065, 2099 South Main Street (CPC Recommendation: Approval - 8 Yeas and 1 Nay). Approval of this resolution will allow for the construction 454 dwelling units in several stacked flat apartment buildings and five townhouse buildings.
- Public Hearing and Resolution to Adopt the Ann Arbor Moving Together Towards Vision Zero City of Ann Arbor Comprehensive Transportation Plan (Adopted and Recommended by the CPC on April 20, 2021 9 Yeas, 0 Nays). Chapter 8 of the City Code directs that the Planning Commission to prepare and adopt, and the City Council to adopt a master plan for the development of the City. Consistent with these regulations and the Michigan Planning Enabling Act, the City has developed the Ann Arbor Moving Together Towards Vision Zero City of Ann Arbor Comprehensive Transportation Plan.

#### Ordinances – Second Readings (2)

• An Ordinance to Amend Section 5.15 (Table 5-15-2) and Section 5.16.6 of Chapter 55 (Unified Development Code) of Title V of the Code of the City of Ann Arbor (Accessory Dwelling Units) (ORD-21-14). On August 4, 2016, the City Council adopted Ordinance 16-16, which amended the Zoning Ordinance to convert Accessory Apartments into Accessory Dwelling Units and create additional standards. Component to this ordinance was the establishment of ADUs as an Accessory use in the R1A through R1E, and R2A Zoning Districts.

To date, realization of such units in the City has been minimal. In 2019, the City Council defeated a series of proposed amendments to the ordinance, that were considered in response to City Council direction. Subsequently, the City Planning Commission maintained proposed amendments to the Ordinance on its work program, which resulted in the following recommended amendments to the Unified Development Code:

- Addition of more zoning districts where ADUs are allowed. The proposed amendments add
  the option to all residential zoning districts, excepting R6 Mobile Home Parks. The addition
  of ADUs to other zoning districts does not eliminate the requirement of any location being a
  single-family property.
- Amend the requirements that previously limited detached ADUs on those properties that
  had an existing accessory structure prior to December 31, 2016. The amendments allow a
  detached ADU in any legally conforming detached accessory structure.
- Removal of requirement that any new entrance be located on the side or rear of a structure.
- Removal of minimum 5,000 square feet lot size requirement.
- Reordering of the requirements into more logical groupings
- Removal of additional parking requirements as the majority of proposed ADU's are within ¼
  mile of a bus stop.
- Removal of the requirement that the owner of the property resides on the property, and removal of the corresponding deed restriction requirement.
- Ensure the maximum occupancy is maintained.
- An Ordinance to Amend Chapter 55 (Unified Development Code), Rezoning of 9.8 Acres from TWP(Township), R1C (Single-Family) and R1A (Single-Family) to R4E With Conditions (Multiple-Family Dwelling District with Conditions), Valhalla Ann Arbor Conditional Rezoning, 31, 50, 57, 77, 97, 98, 107, 145, 147, 151, 155, 159, 163 Valhalla Drive and 2065, 2099 South Main Street (CPC Recommendation: Approval 8 Yeas and 1 Nay) (ORD-21-15). Approval of this resolution will rezone parcels totaling 9.8 acres from TWP (Township), R1C (Single-Family) and R1A (Single-Family) to R4E with Conditions (Multiple-Family Dwelling District with Conditions) to allow the site to be redeveloped for residential use.

### Ordinances – First Readings (4)

- An Ordinance to Amend Section 8:530 of Chapter 105 (Housing: Entry to Show Premises and Time for Rental Agreements) of Title VIII (Building Regulations) of the Ann Arbor City Code. The proposed ordinance amendment increases the period of time that landlords are prohibited from entering leased premises for the purpose of showing the premises to prospective tenants, and entering into a lease to rent the premises to another tenant for a subsequent lease period, from 70 to 240 days.
- An Ordinance to Amend Chapter 112 (Non-Discrimination), Section 9:151, Title IX of the Code of the City of Ann Arbor to Add Definition of Race to Include Prohibition Against Race-Based Hair Discrimination. This ordinance adds the definition of race and protective hairstyles.
- An Ordinance to Add Sections 5.12.9 and to Amend Sections 5.15, 5.16.3, 5.17.4 and 5.20.4
   of Chapter 55 (Unified Development Code) of Title V of the Code of the City of Ann Arbor
   (New Zoning District TC1 Transit Corridor). An amendment is proposed to the Unified

Development Code to add a new zoning district, TC1 (Transit Corridor) district, and establish permitted uses, use specific standards, and dimensional standards, as well as related amendments and revisions for consistency. It is offered by the Planning Commission in response to Council Resolution R-20-439 which asked for a transit-supported zoning district to increase housing density and options along major corridors, examining certain solutions, and preliminary recommendations for geographic areas to consider for such designation, by June 15, 2021.

• An Ordinance to Amend Sections 5.18.3, 5.18.4, 5.17.3, 5.37.2.A and 5.37.2.S, to Add Sections 5.19.6 and 5.33.6, and to Repeal Sections 5.30.1 and 5.30.4.B of Chapter 55 (Unified Development Code) of Title V of the Code of the City of Ann Arbor (Planned Project Site Plan Modifications). Amendments are proposed to the Unified Development Code to eliminate the Planned Project Site Plan Modifications provisions and offer additional flexibility in setbacks and height. These amendments are intended to replicate the majority of benefits offered and realized by the current Planned Project Site Plan Modifications in a less complicated, more straightforward, predictable and intuitive manner.

#### Other

Juneteenth Added as a City Holiday. City Council approved adding Juneteenth as a city holiday via Resolution R-21-182. Juneteenth is a holiday marking the end of slavery in the United States, following its establishment on the North American mainland in 1619. City leadership and staff will observe Juneteenth the Friday prior to the formal, recognized day of celebration for Juneteenth on the third Saturday of June each year, and that Larcom City Hall shall be closed on that day; collection of trash/recycling/compost will not be delayed.

June Water Quality Matters. The June issue of Quality Water Matters brings awareness to National Dam Safety Awareness Day, which was on May 31. The issue highlights several projects at the city's dams that will ensure their continued safety and function as well as emergency preparedness evacuation tips for our community. A City of Ann Arbor initiative is underway to help ensure the city functions in a more inclusive manner and that there are opportunities for community members to have their voices heard. Ann Arbor's Road Construction Season and Planned 2021 Road, Sidewalk, Utility and Resurfacing Projects. Ann Arbor's 2021 road construction "season" is ongoing with many

projects underway and more to come this summer and fall. This year's projects include resurfacing/restoration of nearly 9 miles of roads, 6.2 miles of preventative maintenance and 5,700 feet of new sidewalk construction. July Events with NAP. City of Ann Arbor Natural Area Preservation (NAP) works to protect and restore Ann Arbor's natural areas and to foster an environmental ethic among its citizens. This involves conducting plant and animal inventories, ecological monitoring and stewardship projects in Ann Arbor's parks. These tasks are performed by both staff and volunteers. **17-year Cicadas.** Ann Arbor, along with large parts of the Midwest and eastern United States, are experiencing a 17-year cicada emergence. The cicadas, which do not bite and are harmless to humans, will present challenges to smaller saplings while benefiting larger and established trees. # One Year of A<sup>2</sup>ZERO



### **Overview**

 $A^2ZERO$  is Ann Arbor's plan for achieving a just transition to community-wide carbon neutrality by 2030. Adopted by City Council in June of 2020,  $A^2ZERO$  is an audacious and essential plan, framework, and series of programs that will help improve health, safety, and comfort, all while helping our community achieve deep decarbonization.

 $A^2ZERO$  is a living plan, meaning that it's important to regularly reflect on what is working, what needs to be adjusted, and what needs to be added. This document presents one such reflection - looking back on the first year of  $A^2ZERO$ , the accomplishments, the short comings, and the next steps.



### Strategy 1: Power our electrical grid with 100% renewable energy

- Installed approximately 1.3MW of rooftop solar on over 200 residential roofs, saving residents over \$650,000 on upfront costs
- Launched the Solarize Toolkit, a step-by-step guide to implementing the Solarize model in other communities
- Helped negotiate agreements on community solar, Voluntary Green Pricing (VGP) programs, and carbon reduction offerings - allowing customers to have more control over where their energy comes from
- Began developing a low-to-moderate income (LMI) solar access program and won a National Community Solar Partnership (NCSP) grant for technical assistance on this program
- Conducted studies on the feasibility and cost of a 24MW solar installation on a capped landfill
- Launched a municipal rooftop solar Request For Proposals (RFP) related to the installation of solar at thirteen municipal facilities
- Achieved SolSmart Silver designation for our efforts to make going solar faster, easier, and more affordable
- Crafted core criteria and principles for achieving our renewable energy goals
- Regularly participated in Michigan Public Service Commission working groups















### Strategy 2: Switch our appliances and vehicles from fossil fuels to electric

- Transitioned 10% of our light duty City fleet to electric, including making our first purchase of electric vehicles (EVs) for the Police Department
- Expanded public EV charging infrastructure, including winning a grant to install 4 Direct Current Fast Chargers (DCFCs) at City Hall
- Developed and implemented an EV Readiness Ordinance, requiring new developments to include EV charging infrastructure in site planning
- Initiated a heat pump replacement campaign, including a sticker program to ease the transition process to electric
- Developed a range replacement program, which reduces barriers to the adoption of induction ranges through supply and demand side partnerships
- Initiated a collaboration with IBEW 252 to create a home electrification assessment



### Strategy 3: Significantly improve the energy efficiency in our buildings

### In Year One, we:

- Completed energy audits of 6 City facilities
- Designed and launched a pilot of our Aging in Place Efficiently program, which aims to improve energy efficiency and comfort in the homes of older adults
- Drafted a commercial and multi-family benchmarking ordinance, as well as a home energy disclosure ordinance, including input sourced from stakeholder engagement
- Launched a decarbonization initiative with the Bryant neighborhood and Community Action Network, to co-create a whole home health, safety, comfort, and decarbonization assessment
- Introduced updates to our permitting system to better track our energy efficiency progress
- Worked with the International Code Council (ICC) to introduce Building Code Committees and volunteered to serve on these committees
- Participated in the scoping and evaluation for the zero energy fire station design
- Organized a cohort for a consumption-based emissions inventory

### Strategy 4: Reduce the miles we travel in our vehicles by at least 50%

- Launched a bike discount program to reduce barriers to bike access and encourage alternative modes of transportation
- Coordinated the donation of bikes to Common Cycle
- Supported the development of the Vision Zero plan

### Strategy 5: Change the way we use, reuse, and dispose of materials

### In Year One, we:

- Launched a reusable container pilot with four restaurants during
   Green Fare, in an effort to reduce food container waste
- Published, in conjunction with the Public Works Department, a paper on the circular economy - which aims to decouple resource consumption from economics - in the journal Sustainability.

### Strategy 6: Enhance the resilience of our people and our place

- Developed and launched the 10,000 Trees Initiative and planted over 1,000 trees - improving our City's resilience to climate change through green infrastructure
- Secured grant funding for the planting of trees in underserved neighborhoods
- Created the Ambassadors program and trained 22 community members as A<sup>2</sup>ZERO Ambassadors.
- Supported our Ambassadors in designing and implementing seven sustainability-focused community projects
- Developed educational materials the Ambassadors are using in their neighborhoods
- Created a resilience hub at Northside Community Center, where a solar powered battery storage system provides up to three days of power in case of an outage
- Secured grant funding for the creation of another resilience hub
- Collaborated with the American Society of Adaptation Professionals on a project to analyze climate-based migration into the Great Lakes region

## Strategy 7: Other strategies / accomplishments

- Secured 92 organizations as collaborators
- Launched RE4M, a 4-part internal learning series focused on how to pair renewable energy, efficiency, electrification, and equity into a program for all Ann Arborites
- Supported the creation of the City's equitable engagement initiative
- Continued the Sustaining Ann Arbor Together grant program, a vehicle for supporting our community's innovation and creativity as it relates to advancing local sustainability and climate action
- Were recognized as a finalist for the America's Climate Leadership Award
- Crafted and launched an A<sup>2</sup>ZERO Pledge for community members to commit to joining us in achieving our sustainability goals
- Engaged with community members and provided guidance and education on sustainability-related issues through the following avenues:
  - Our Sustainability Forum series
  - Our Climate, Coffee, and Conversation open discussions
  - Our revised website
  - The launch of our YouTube channel
  - $\circ$  A<sup>2</sup>ZERO Week, a celebration of the one-year anniversary of the adoption of the A<sup>2</sup>ZERO Plan
  - Regular neighborhood association meetings
  - The OSI stall at the Farmer's Market
  - Our 51st-annual Earth Day celebration
  - An inaugural Juneteenth Celebration in conjunction with the Ann Arbor Branch of the NAACP
  - A presentation at the 2021 Michigan Sustainability Conference
  - A keynote speech at the Washtenaw Community College Climate Summit
- Participated in the Environmental Rules Review Committee
- Joined multiple committees helping develop the MI Healthy Climate Plan for the State of Michigan
- Served on UM's Presidents Commission on Carbon Neutrality
- Launched a Carbon Neutrality Coordinating Committee

### **Next Steps**

As we look forward to Year Two of A<sup>2</sup>ZERO, we anticipate a series of new initiatives, the scaling of existing programs, and the continued expansion of our community engagement efforts, including the growth of our collaborators network. Some of the things currently planned for year two include:

- A community solar pilot
- Expansion of Solarize to commercial enterprises
- The creation of a new low to moderate income solar program
- Support for our Equitable Engagement Steering Committee
- The launch of a whole home "check-up" to help individuals understand their efficiency, electrification, and renewable energy options
- The installation of more bike lanes throughout the City
- The installation of more electric vehicle and bike charging infrastructure
- Energy efficiency improvements at City facilities
- Solar installations at multiple City facilities
- The commissioning of the City's first all electric refuse truck
- The training of our second Ambassadors cohort
- Expansion of our reusable container pilot
- Creation of a working group on utility carbon reduction offerings and voluntary power reduction offerings
- Launch of the BranchOut program and more FreeTree Giveaways
- Continued monitoring, intervention, and testifying before the Michigan Public Service Commission and State House and Senate Committees on relevant legislation or policies
