NOTICE OF PUBLIC HEARING TO REZONE 2800 JACKSON ROAD HOTELS PROPERTY (2800 JACKSON ROAD)

The Ann Arbor City Council will conduct a public hearing at **7:00 p.m.** on **Monday, August 17, 2020,** to hear all those interested in the proposed Ordinance No. ORD-20-23 – 2800 Jackson road Hotels Rezoning. This ordinance would rezone 4.5 acres from R5 (Hotel District) to C3 (Fringe Commercial District), located at 2800 Jackson Road.
