I am sharing language in advance as a courtesy for your review, but will ask Clerk Beaudry to re-circulate during the meeting as well. The most significant change is to the deadline given to Energy Commission, shifting the date by which we request their recommendation from next week to December 31, upon the completion of previously scheduled sessions related to this topic. Thank you. - Travis

<u>DC-1 Substitute: Resolution Directing the Energy Commission to Consider the Question of a Feasibility Study Regarding a Public Power Utility</u>

Whereas, the Energy Commission unanimously endorsed and Ann Arbor City Council unanimously adopted the A2ZERO Carbon Neutrality Plan and the goal of achieving community-wide carbon neutrality by the year 2030;

Whereas, in early 2021 the Energy Commission and Ann Arbor City Council adopted Energy Principles and Criteria to help guide the City's energy-related decision making;

Whereas, the Ann Arbor Energy Commission identified a series of energy-related initiatives that may be useful to help achieve the A2ZERO Plan and that may align with Energy Commission- and City Council- adopted Energy Principles and Criteria;

Whereas, the Energy Commission established a prioritized work plan to evaluate those initiatives;

Whereas, the Energy Commission has been systematically and purposefully reviewing and learning about its top-voted energy procurement, energy technology, and energy policy options to understand their appropriateness for the City of Ann Arbor in light of state law constraints, local conditions, and resource scarcity;

Whereas, the October 2021 meeting of the Energy Commission is dedicated to learning about municipalization efforts, processes, lessons learned, and other pertinent details;

Whereas, the October 2021 meeting of the Energy Commission was scheduled to accommodate the availability of speakers from two communities who have undertaken municipalization initiatives in the last two decades and, as such, are able to share their experience and answer questions;

Whereas, the Energy Commission, especially the chair and co-chair, have been deliberate in ensuring the commissioners have relevant information to make informed recommendations to City Council;

Whereas, City Council recognizes the value of receiving a fully-informed and well-reasoned recommendation from the Energy Commission upon the completion of all previously-scheduled work on this topic, including the learning session in October 2021;

Resolved, Ann Arbor City Council applauds the Energy Commission for its purposeful, intentional, and efficient process of undertaking due diligence on energy-related issues;

Resolved, Ann Arbor City Council requests the Energy Commission to provide a recommendation no later than December 31, 2021 as to whether or not the Commission believes the City should undertake a feasibility study to understand options related to creating a municipal utility, including traditional and non-traditional models;

Resolved, That any such recommendation is requested to explicitly discuss how municipalization and/or municipal utility options align with the goal of community-wide carbon neutrality by 2030 and adheres to the Energy Principles and Criteria adopted by Council, and should provide the Commission's perspectives on the advantages, disadvantages, and value propositions of each;

Resolved, That any such recommendation is requested to explicitly discuss how it would be sustainable, equitable, and transformative, which are three core values outlined in A2ZERO.

Thank you for unanimously approving the resolution to the Energy Commission regarding an electric municipalization feasibility study. I like the direction, but the process was a bit baffling. At least it got the municipalization issue formally on the City agenda.

Hopefully, all of this feasibility analysis work can be completed in time, so that if a Climate Millage moves forward, it gets adjusted for any mini-bonds used for municipalization, as a result of the feasibility assessment.

Please provide funding for a City membership to the American Public Power Association, based on the information I previously shared.

Ann Arbor for Public Power (A2P2) has a fundraiser this Thursday, September 9th, 5 - 9 pm, at Burns Park. Mayor Taylor and City Council:

I am writing with regard to Tuesday's Council agenda item "Energy Commission Feasibility Study Request".

First of all, I view this as an urgent matter that should be treated as a high priority, given the Council's 2019 Climate Emergency resolution, let alone due to the recent climate events that have impacted Ann Arbor residents and businesses with increasing ferocity.

I understand there will be an amendment offered on Tuesday that will provide additional time for the Energy Commission on the proposal for funding a feasibility study. I also understand that the Energy Commission has an existing timeline, and that their agenda is already set by the A2Zero plan execution, with priorities established by the Office of Sustainability and Innovation.

On this basis, I assume that the amendment to extend the date for the Energy Commission to make its recommendation on funding a feasibility study, will most likely be adopted by Council.

Given this, I believe a further amendment is in order, to clarify the expectations City Council has for the feasibility study recommendation, including its objectives, scope and structure. If the time is extended for the Energy Commission to make a recommendation, there should be language in the resolution that defines some of the broad parameters for any feasibility analysis recommended for City Council funding, given the additional time that is being afforded to the Commission.

I believe it would make sense for Council to establish the goals and objectives for the feasibility analysis. Is it just the economics and legal framework, or would there be other elements to the assessment, maybe held in multiple phases?

For example, the scope of the analysis presumably will assess a range of options for municipalization. The options would be assessed based on the feasibility for achieving the objectives identified for municipalization. These objectives could include the rate reduction potential; technical ability to affect reliability and uptime performance; isolating the Ann Arbor grid from DTE's, and the costs required to achieve significantly improved electric grid performance and architectural separation from DTE's grid; ability to achieve 100% renewable energy (technical, legal and economic) for Ann Arbor by 2030 over other alternatives; equity impacts of each option; etc.

The economics of municipalization, that is, the most likely cost to buy-out and separate from DTE, and the length of time it would take to finance the buyout and physically separate from DTE's network, whether through mini-bonds or another millage, would be core to the analysis. Another core element of the analysis would be the legal constraints of municipalization, its operation, and any legal issues on the options framed for achieving 100% renewable energy by 2030.

Given the complexity of a feasibility analysis, and what I gleaned from a review of recent efforts by other cities across the US, one could also expect a couple phases to the feasibility assessment. This is to be expected, as there will be a number of gates required before a full adoption, including a City-wide vote, of course. The first phase may just address the economics and legal challenges, with a second phase to conduct a deeper level of analysis on the addition elements (i.e., reliability / uptime performance, rate reduction potential, voter approval, etc.). A third phase may be on the governance

structure, its board-level framework, and management structure with regard to other City departments.

While Council should not attempt to detail the work of the Energy Commission on this matter, I believe setting some of the broad parameters will help provide direction. Setting expectations as to (1) the goals and objectives for municipalization, and hence the feasibility analysis, (2) having a range of options considered, and (3) identifying potential phasing of additional assessments, will improve the outcome. Getting this level of detail back from the Energy Commission will facilitate the contracting phase, and should shorten the time it takes to award the contract and get the initial / preliminary feasibility study completed. Waiting to structure the feasibility analysis until after the Energy Commission's funding recommendation will only further extend the timeline for the feasibility assessment results.

The exact wording of any further amendment I will leave to one of you to consider and propose.

In closing, I am listing a key resource, the American Public Power Association. I recommend a City membership for supporting the work of the Energy Commission and OSI staff.
