## **NEW BUSINESS**

1. **10-0727** Small Farm Subcommittee Slide Presentation

Ginny Trocchio said that the Small Farms Committee met a number of times over the past year. The two major topics discussed were easement terms and future ownership of property. The discussion on easement terms asked the question of whether changes or alterations were needed in order to make them more suitable for smaller farms. The topic of future ownership of property brought on concern with future property being transferred to a non-farm owner and possibly being converted into someone's estate.

*Ms.* Trocchio gave a slide presentation regarding small farms and gave a breakdown of the easement terms. She also explained the concerns with future ownership in more detail. A copy of the presentation is on file in the City Clerk's Office.

Staff recommended moving forward with additional language and amending the amendment clause in the Conservation Easement Terms. The Commission agreed to discuss and recommend new language regarding the Conservation Easement terms at their next meeting.

## 2. <u>Staff Updates</u>

*Ms.* Trocchio said that the Farm and Ranch Land Protection Grant deadline is July 1, 2010 and they are preparing several applications.

She also informed the Commission that the Parks and Recreation Open Space Plan is currently undergoing its 5-year update. There is a section on land acquisition which includes this millage. Citizens will receive a survey in the mail soon.

*Ms.* Trocchio announced that The Food System Economic Annual Conference is scheduled for June 24, 2010. Log onto www.michigan.org for additional information.
