M1 currently permits a public school, child care center, adult day care, libraries, and other uses that have similar levels of use intensity and generates similar amounts of traffic. The use fits with the general intent statement of the district in that religious assembly will "emit a minimum of noise, vibration, smoke, dust, dirt" and will have compatibility with child care centers, libraries, etc.
