Thank you for your email. I had to read a few newspaper articles via Google search to understand what are your goals. I propose that you if you want high-rise buildings, then do it on top of the Briarwood mall, where it obstructs no one's sun. If you learn more about the history of Ann Arbor, this complaint has been common among its denizens for centuries: https://aadl.org/aaobserver/15599. I lived at the Forest Plaza mentioned in this article, and the referenced professors were right on every point that they made against building the multi-story building there. Furthermore, living in such a multi-story building does not do well for its denizens, as you hear a neighbor at every wall, and the echoes of passersby off the alleyways constructed of neighboring buildings kept one up at night.

One must not forget how well the Tower Plaza is holding up, where its leasees cannot get a good night's sleep because of the constant construction noise created with the attempt to maintain the building's integrity, let alone the lack of fresh air because one cannot open the windows at a higher height.

Returning back to Brairwood mall: The city should own the air rights and lease it out to potential lessors to avoid the increase of privileged real estate owners. They treat their lessees terribly, anyway. Enough is enough. People should not live off of other people's rent to them and do the bare minimum to maintain them. If the city own the property, they can kick out bad real estate people, including those who get together to form a pact to jack up the rental units together.

The President of the University of Michigan help these people because there is plenty of space around the current North Campus housing to build more for their students, but he does nothing.

While building a multi-story parking garage along with the proposed high-rise of the Brairwood mall is not ideal, it is practical to deal with the vehicles of the potential owners, for the weather is freezing in Michigan, and there are long stretches of road between cities in the state, making owning a vehicle more practical.
