Wurster Park Black oak Fertilization - Tiffany Giacobazzi

The committee and staff would like to assess the tree this spring/summer to see if fertilization treatments should be continued. The tree is showing signs of decline even with the years of fertilization treatments. They will consider fall fertilization treatment once the tree inspection has been completed.

Wieland moved to approve the \$248.00 spring fertilization of the Wurster Park black oak tree by Guardian Tree Experts. Curtis seconded. Motion passed unanimously.

3 Year Plan Discussion - Chairperson Wieland

Priority 1: Tree Planting

- Housing Commission rights-of-way (ROW) planting: Staff found 282 vacant planting sites within 500 feet of Housing Commission Properties or other low-cost housing initiatives. The committee is interested in pursuing this project. They ask staff to analyze the data to spread the plantings over two years. Staff will report out at the March meeting.

Priority 2: Maintenance & Other Activities

- Pruning Leslie Park trees near food forest: Staff will assess the trees near the food forest in Leslie Park to see if they need care/maintenance and report back to the committee by the April meeting.

- Mushroom Park: Staff will assess oak trees in Mushroom Park this spring, after leaf-out, to see if they need any specialized treatments/maintenance activities. Staff will report back to the committee by the July meeting.

Housing Commission ROW Planting Update - Jamie Pauline

Projects for FY2025 Discussion - Group

Projects for 2025:

- Mini forests/food forests: The committee is interested in pursuing a mini-forest or food forest project in one of the parks.

- Housing Commission ROW planting: The committee is interested in pursuing tree planting adjacent to Housing Commission and other low-cost housing sites.

- Enhance (smaller) neighborhood parks: The committee is interested in partnering with community centers or Adopt-A-Park to enhance small neighborhood parks that are in need of tree care, planting, and/or maintenance. They would like to focus on "what would enhance the park for the residents?"

- Bicentennial Park: The committee is interested in supporting the working happening in Bicentennial Park for the City's bicentennial celebration. Parks staff to report on this to the committee at the March meeting.

10,000 Trees Initiative & Community Action Network - Chairperson Wieland

Wieland connected with organizations that could benefit from participating in the 10,000 Trees Initiative. Staff will include the 10,000 Trees Initiative information in outreach to Community Action Networks. The committee will continue to promote this initiative with the groups they work with.

Wieland moved to cancel the July Elizabeth Dean Fund Committee meeting. Curtis seconded. Motion passed unanimously.
