City Council meets in caucus the Sunday prior to each regular session at 7 p.m. in the Council Chamber.

CALL TO ORDER

Mayor Hieftje called the meeting to order at 7:12 p.m. in the Washtenaw County Board of Commissioners meeting room, 220 N. Main Street.

MOMENT OF SILENCE

Council stood for a moment of silence.

PLEDGE OF ALLEGIANCE

Mayor Hieftje led Council in the recitation of the Pledge of Allegiance.

Mayor Hieftje read proclamations honoring Phi Beta Sigma Fraternity-Delta Rho Chapter as February Natural Areas Preservation Volunteer of the Month and to Peter Pollack's legacy, honoring his contributions to the community. Copies of the proclamations are on file in the City Clerk's Office.

1. TJ Rice - Medical Marijuana Ordinance (C-1)

TJ Rice, 202 E. Washington, addressed Council regarding the proposed medical marijuana ordinance. He said his biggest concerns with the ordinance are issues surrounding patient privacy.

2. Dennis Hayes - Medical Marijuana Ordinance (C-1)

Dennis Hayes expressed concern with the proposed medical marijuana ordinance regarding patient and caregiver lists. He urged Council to draft the ordinance in compliance with the voter-approved City Charter amendment.

3. Tony Keene - Medical Marijuana Ordinance (C-1)

Tony Keene, 240 Crest Street, spoke in support of the proposed medical marijuana ordinance. He urged Council to ban dispensary operations, stating they are unneccessary and are giving the entire medical marijuana community a bad name.

4. Thomas Partridge - Overcome discrimination. Provide access to safe affordable housing and transportation (DC-1 and DS-1)

Thomas Partirdge, Ann Arbor resident, addressed Council regarding overcoming discriminiation and providing access to safe affordable housing and transportation.

5. Rory Gould - Medical Marijuana Ordinance (C-1)

Rory Gould, 5537 Overbrook, representing Arborside Health and Wellness, addressed City Council regarding the proposed medical marijuana ordinance. He said that the current proposal would limit the number of dispensaries and may affect the quality of marijuana that is made available to patients.

6. Chuck Ream - Medical Marijuana Ordinance (C-1)

Chuck Ream, 1911 Packard St., said that Chapter 16 of the City Charter should be included in the ordinance. He also expressed concern about privacy issues due to the creation of patient lists.

7. Peter Nogourney - Design Guidelines (DC-2)

Peter Nagourney, 914 Lincoln, thanked Council for their support of the Design Guidelines process and encouraged Council to support its continued development.

COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER HOHNKE

Councilmember Hohnke introduced the resolution to appoint Susan Hutton to fill the vacancy on the Environmental Commission. He stated the resolution would return to Council at the next regular session (File No. 11-0232). Councilmember Hohnke added that another vacancy on the Environmental Commission is expected by the end of the month; he encouraged interested citizens to fill out an application.

COUNCILMEMBER BRIERE

Councilmember Briere stated that she was pleased to finally see the Design Guidelines on the agenda; however, she expressed concern with the lateness of the addition to the agenda.

Ms. Briere gave an update on the Street Outreach Committee. She said that the committee has finished all of its factfinding and is in the process of creating a report that may be presented to Council in early March 2011.

COUNCILMEMBER TAYLOR

Councilmember Taylor reported on the status of the Mutually Beneficial Committee and the DDA Mutually Beneficial Committee. The DDA is working on amendments to the parking agreement and Councilmember Taylor stated he expects to receive a draft for review with the committees soon.

Mr. Taylor also reported on the Burns Park Players Community Theater event that took place last weekend entitled "How to Succeed without Really Trying". The group is planning another performance again this weekend and members of the community are encouraged to attend.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

MUNICIPAL CENTER

City Administrator Roger Fraser announced that the Police Department and the 15th District Court have moved into the new Justice Center. Police Patrol is still stationed at the Wheeler Center and awaiting their move into the new building. Site work on the south side of the Larcom building continues and the basement of Larcom is nearly complete.

Mr. Fraser also announced that the City Clerk's Office will receive carpeted flooring, due to additional asbestos work that was required after floor tiles were disrupted during the construction work on the 2nd Floor of Larcom.

Libby Hunter, 827 Bruce Street, serenaded Council, to the tune of the University of Michigan fight song, in opposition to the proposed Fuller Road Station as part of the Capital Improvements Plan.

Andrew McGill, 5221 Crooked Stick Drive in Pittsfield Township, addressed Council regarding the Ann Arbor Municipal Airport extension project. He asked that Council remove this line item from the CIP, as it was last year, until the Environmental Assessment study can be fully completed.

Thomas Partridge, Ann Arbor resident, called upon City Council and Washtenaw County Board of Commissioners to incorporate accessibility planning in the CIP.

Joel Batterman, 1512 Gilbert Ct., asked that Council reconsider the Fuller Road Station Phase I Project, while the City and the University take another look at the issues surrounding commuter parking.

Christopher Gordon, of 7396 Brass Creek Dr., Dexter, Ml, President of the Ann Arbor General Aviation Association, spoke in support of the Ann Arbor Municipal Airport projects included in the Capital Imporvements Plan.

There being no further comment, the Mayor declared the hearing closed.

COMMUNICATIONS FROM COUNCIL

COUNCILMEMER RAPUNDALO

Councilmemer Rapundalo stated that he wanted to address some comments that were attributed to him on AnnArbor.com. Councilmember Rapundalo said that no member of the labor committee or City Council is directly involved with negotiations between the City and its unions. Collective bargaining is left to the discretion of the City Administrator. Council's role and the Labor Committee's role is to set parameters and give guidance as requested.

Councilmember Rapundalo also noted that it was suggested that only the firefighters' union had given concessions to the City. Mr. Rapundalo stated this is not true, as the

non-union employees and some other bargaining groups have also made concessions in the past. He noted that the firefighter concessions were temporary, lasting 6 months, and it was not agreed upon to continue them.

Councilmember Rapundalo stated a third issue raised in the article was surrounding Act 312 arbitration. Councilmember Rapundalo stated that it was suggested that the City does not negotiate and instigates arbitration. He stated this is not true. The union contracts continue expired and the unions have little incentive to negotiate in some cases.

Mr. Rapundalo stated staff provided him with some comparisons regarding health care coverage. He stated that the non-union employees, as well as several bargaining units who have settled with the City, are now paying increased deductibles, co-pays and premiums. In contrast, the City's Fire, Police, Command Officers, and AFSCME employees pay only a very small annual deductible (\$250.00) and no other out-of-pocket costs. Staff also compared the City's costs to the University of Michigan employees' costs and found that the union employees at the City are paying considerably less.

COUNCILMEMBER HIGGINS

Councilmember Higgins announced that the Dicken Woods Annual Walk would take place on February 15, 2011 from 7-8 p.m. Those interested in participating can meet at Dicken School.

An Ordinance to Add a New Chapter 71 to Title VI (Medical Marijuana Business and Home Occupation Licenses) of the Code of the City of Ann Arbor

A motion was made by Councilmember Briere, seconded by Councilmember Derezinski, that the ordinance be approved at First Reading.

Enactment No: ORD-11-04

A motion was made by Councilmember Briere, seconded by Councilmember Smith, that the Ordinance be amended as follows:

Section 6:414. Definitions.

- ... (b) Cultivation of facility means a medical marijuana cultivation facility
- (d) Medical marijuana cultivation facility. [A single facility where more than 72 marijuana plants are being grown.] A STRUCTURE OR EACH SPACE IN A STRUCTURE THAT IS SEPARATELY OWNED OR LEASED BY A PERSON OTHER THAN THE OWNER OF THE STRUCTURE, IN WHICH MARIJUANA PLANTS ARE BEING CULTIVATED OTHER THAN AS A MEDICAL MARIJUANA HOME OCCUPATION.

Note: [] Brackets indicate deleted language, all CAPS indicate new language.

On a voice vote, the Mayor declared the motion carried, with no votes made by Councilmember Higgins and Rapundalo.

A motion was made by Councilmember Briere, seconded by Councilmember Teall, that the Ordinance be amended as follows:

Section 6:414. Definitions

- ...(e) Authorized person means:
 - (i) AN OWNER OF A DISPENSAR OR CULTIVATION FACILITY;
- (ii) THE DIRECTORS, OFFICERS, MEMBERS, PARTNERS, AND INDIVIDUALS OF A DISPENSARY OR CULTIVATION FACILITY THAT IS A CORPORATION,
- LIMITED LIABILITY COMPANY, PARTNERSHIP, OR SOLE PROPRIETORSHIP:
- (iii) ANY PERSON WHO IS IN CHARGE OF AND ON THE PREMISES OF THE DISPENSARY DURING BUSINESS HOURS.

On a voice vote, the Mayor declared the motion carried.

A motion was made by Councilmember Briere, seconded by Councilmember Teall, that the Ordinance be amended as follows:

Section 6:415. License required, Number of Licenses available, Eligibility.

...(4) The first year's license shall be capped at a number 10% higher than the licenses applied for in the first 60 days, but not more than 20 dispensaries and 10 cultivation facility licenses. Any license terminated during the license year returns to the City for POSSIBLE reissuance. A BUSINESS THAT IS A COMBINED DISPENSARY AND CULTIVATION FACILITY SHALL REQUIRE TWO

SEPARATE LICENSES.

On a voice vote, the Mayor declared the motion carried.

A motion was made by Councilmember Briere, seconded by Councilmember Derezinski, that the Ordinance be Amended as follows:

Section 6:416. General Provisions.

...(4) BEFORE THE CITY OFFICIALLY ISSUES A LICENSE, THE APPLICANT SHALL PROVIDE THE CITY WITH PROOF OF INSURANCE IN THE FOLLOWING TYPES AND AMOUNTS:

(A) ; (B) ; (ETC).

On a voice vote, the Mayor declared the motion carried.

A motion was made by Councilmember Briere, seconded by Councilmember Smith, that the Ordinance be amended as follows:

Section 6:417. Application for and Issuance of New Annual License or Renewal of Existing License for Medical Marijuana Dispensaries and Medical Marijuana Cultivation Facilities.

...(2)(f) [Name and address of all physicians who will render services on the premises of the cultivation facility or dispensary.]

On a voice vote, the Mayor declared the motion carried with no votes made by Councilmembers Higgins and Rapundalo.

A motion was made by Councilmember Briere, seconded by Councilmember Kunselman, that the Ordinance be Amended as follows:

Section 6:416. General Provisions.

...[(j) A description of the products and services to be provided.]

The following new language was proposed:

THE APPLICANT MUST IDENTIFY WHETHER THEY ARE APPLYING FOR A DISPENSARY LICENSE OR CULTIVATION FACILITY LICENSE.

This proposed change was withdrawn.

The question being, the motion to delete section 6:417 (2)(j), on a roll call, the vote was as follows with the Mayor declaring the motion carried:

Section 6:416. General Provisions.

...(I) [Proof that t] The following security measures [have been] SHALL BE installed on the premises:

(i) security cameras to monitor all areas of the licensed premises where persons may gain or attempt to gain access to marijuana or cash. Recordings from security cameras shall be maintained for a minimum of seventy-two hours [in a secure off site location]. THE ADMINISTRATOR MAY ADOPT REGULATIONS IMPLEMENTING THIS REQUIREMENT, INCLUDING BUT NOT LIMITED TO REGULATIONS ON THE DESIGN, LOCATION, MAINTENANCE, AND ACCESS TO THE CAMERAS AND RECORDINGS. THOSE REGULATIONS SHALL TAKE EFFECT 30 DAYS AFTER BEING FILED WITH THE CITY CLERK UNLESS MODIFIED OR DISAPPROVED BY THE CITY COUNCIL.

Section 6:419. Conduct of Business at Cultivation Facility or Dispensary.

...(4)(e) the warning that:

THIS PRODUCT IS MANUFACTURED WITHOUT ANY REGULATORY OVERSIGHT FOR HEALTH, SAFETY OR EFFICACY. THERE MAY BE HEALTH RISKS ASSOCIATED WITH THE INGESTION OR USE OF THIS PRODUCT. USING THIS PRODUCT MAY CAUSE DROWSINESS. DO NOT DRIVE OR OPERATE HEAVY MACHINERY WHILE USING THIS PRODUCT. KEEP THIS PRODUCT OUT OF REACH OF CHILDREN. THIS PRODUCT MAY NOT BE USED IN ANY WAY THAT DOES NOT COMPLY WITH THE MICHIGAN MEDICAL MARIJUANA ACT OR BY ANY PERSON WHO DOES NOT POSSESS A VALID MEDICAL MARIJUANA PATIENT REGISTRATION CARD.

On a voice vote, the Mayor declared the motion carried.

A motion was made by Councilmember Briere, seconded by Councilmember Teall, that the Ordinance be amended as follows:

Section 6:419. Conduct of Business at Cultivation Facility and Dispensary.

...(6) [No person] AN AUTHORIZED PERSON shall [fail to] consent to the entry into a cultivation facility or dispensary by the Building Official and zoning inspectors for the purpose of inspection to determine compliance with this chapter pursuant to a notice posted in a conspicuous place on the premises two (2) or more days before the date of the inspection or sent by first class

mail to the address of the premises four (4) or more calendar days before the date of the inspection.

On a voice vote, the Mayor declared the motion carried.

A motion was made by Councilmember Briere, seconded by Councilmember Anglin, that the Ordinance be amended as follows:

Section 6:419. Conduct of Business at Cultivation Facility or Dispensary.

...(7) [No person shall fail to maintain all security measures required in this chapter in good working order or fail to keep the premises monitored and secured twenty four hours per day.] ALL SECURITY MEASURES REQUIRED IN THIS CHAPTER SHALL BE MAINTAINED IN GOOD WORKING ORDER. THE PREMISES SHALL BE MONITORED AND SECURED TWENTY-FOUR HOURS PER DAY.

On a voice vote, the Mayor declared the motion carried.

A motion was made by Councilmember Smith, seconded by Councilmember Derezinski, that the Ordinance be amended as follows:

Section 6:419 Conduct of Business at Cultivation Facility or Dispensary.

...(9) A cultivation facility or dispensary shall keep records [of the persons] CONSISTING OF CAREGIVERS' STATE ID NUMBERS, VOLUME AND TYPE OF PRODUCT AND THE DATE RECEIVED from whom they received marijuana in any form, and shall make the records available to the City for review upon request.

The motion was withdrawn.

Enactment No: ORD-11-04

A motion was made by Councilmember Briere, seconded by Councilmember Smith, that the Ordinance be amended as follows:

Section 6:420 Prohibited Acts.

- ...(d) Make any changes or allow any changes to be made [to] IN THE OPERATION OF the cultivation facility or dispensary [or in the products or services offered,] as represented in the LICENSE application, WITHOUT FIRST NOTIFYING THE CITY BY AMENDING ITS APPLICATION[or the structure or location at which the business is operating without applying for and being issues a new license.]
- (e) MAKE ANY CHANGES OR ALLOW ANY CHANGES TO BE MADE TO THE STRUCTURE IN WHICH THE BUSINESS IS OPERATING WITHOUT APPLYING FOR AND BEING ISSUED APPROPRIATE PERMITS AND OBTAINING FINAL INSPECTION APPROVAL.

A motion was made by Councilmember Taylor, seconded by Councilmember Smith, that the Ordinance be amended as follows:

Section 6:416. General Provisions.

...(2) A cultivation facility or dispensary license issued by the City under this chapter including the name and contact information for [the owner(s) and business manager(s)] AN AUTHORIZED PERSON AND BUSINESS MANAGER(S) IF ANY, shall be conspicuously posted in the cultivation facility or dispensary where it is easily open to public view.
