CALL TO ORDER

Mayor Hieftje called the meeting to order at 7:09 p.m. in the Guy C. Larcom Jr., Municipal Building, 2nd Floor Council Chambers, 301 E. Huron St.

MOMENT OF SILENCE

Council stood for a moment of silence.

PLEDGE OF ALLEGIANCE

Mayor Hieftje led Council in the recitation of the Pledge of Allegiance.

APPROVAL OF AGENDA

A motion was made by Councilmember Higgins, seconded by Councilmember Taylor, that the Agenda be approved as presented. On a voice vote, the Mayor declared the motion carried.

INT-1 11-0420 Proclamation for Jeanine Palms Commemoration & Buhr Park Wet Meadow

Mayor Hieftje read a proclamation commemorating Jeannine Palms and The Buhr Park Children's Wet Meadow Volunteers for their work to improve Buhr Park and the Malletts Creek Watershed by planting and maintaining several gardens and three wet meadows that provide habitat for native plants and animals, an attractive educational site for children, neighbors and other visitors, and an environmental filter for stormwater runoff from the park grounds. Councilmember Rapundalo introduced Paul Krutko, President and CEO of Ann Arbor SPARK. Mr. Krutko introduced himself and said that he was excited to work in the Ann Arbor Community and would be speaking with councilmembers in the near future.

1. Thomas Partridge - Recall Governor Snyder. Support Michigan's most vulnerable residents. Support funding for transportation and human services; and not marijuana.

Thomas Partridge, Ann Arbor resident, encouraged voters to get out to the polls to vote in the May 2, 2011 Election. He also urged Council and the State to support the recall effort for Governor Snyder. Mr. Partridge spoke against medical marijuana.

2. Chuck Ream - Medical Marijuana (B-1)

Chuck Ream, 1818 Packard, expressed concern regarding the City Attorney managing the medical marijuana ordinance process due to potential bias. He also urged Council to remove any requirements for registration of caregivers and to follow the State law on medical marijuana record keeping procedures.

3. Rhory Gould - Medical Marijuana (B-1)

Rhory Gould, 5537 Overbrook Dr., thanked Council and the Mayor for their work on the two medical marijuana ordinances. He urged Council to remove references in the ordinance to record keeping for caregivers and cultivation facilities.

4. Kirk Reid - Medical Marijuana (B-1)

Kirk Reid, PO Box 7891, medical marijuana patient and caregiver, said that he appreciated the work that Council has put into the medical marijuana licensing ordinance. He spoke in opposition to placing his name on any list as a caregiver or a patient. He offered for Council to sit down and discuss the ordinance with him and other caregivers.

5. John Henry Kaiser - Medical Marijuana (B-1)

John Henry Kaiser was not present. A member of the audience submitted a letter to Council regarding his statement. See H-2 for the communication.

6. Dennis Hayes - Medical Marijuana (B-1)

Dennis Hayes, 120 N. Fourth Ave., asked that Council pay attention to the laws that the voters have already approved regarding medical marijuana, especially related to patient and caregiver needs.

7. Lawrence Kestenbaum - May 2011 Election

Lawrence Kestenbaum, Washtenaw County Clerk, announced that tomorrow, Tuesday, May 2, 2011 is Election Day. Clerk Kestenbaum stated that voters would be voting on a renewal of a Washtenaw County Special Education School Millage. He also talked about a proposal that would change elections days from four times a year to twice per year, May and November.

COMMUNICATIONS FROM COUNCIL

MAYOR HIEFTJE

Mayor Hieftje updated Council on the proposed parking agreement between the City and the DDA. The mayor stated that members of staff reviewed language in Chapter 7 of the City Code, which might have bearing upon the parking contract negotiations. The parking agreement resolution for tonight's meeting was removed from the agenda until staff and the City Attorney could further review the implications of the language in Chapter 7.

COUNCILMEMBER DEREZINSKI

Councilmember Derezinski reported on the annual retreat of the City Planning Commission. Councilmember Derezinski reported that the Planning Commission has decided to take a regional perspective on planning issues and consider decision-making in the larger context of the greater Ann Arbor area in collaboration with other communities. The Washtenaw Avenue corridor was also studies at the retreat. AATA provided a bus tour of the area and transportation impacts were discussed.

COUNCILMEMBER TAYLOR

Councilmember Taylor said that the Park Advisory Commission met and reviewed the proposed Parks and Recreation budget and fee schedule. PAC members met with city staff regarding proposed cuts in the service areas that represent parks; Community Services and Public Services. Councilmember Taylor reported that the proposed cuts on the Public Services side are generally in excess of the dollar amount proposed by other units of the City. However, he noted that while costs would be reduced, service cuts were not proposed. PAC has passed a resolution asking City Council to refund the Public Services element of the Parks budget to bring the overall reduction of the Parks budget in line with other unit functions within the City.

COUNCILMEMBER ANGLIN

Councilmember Anglin said that part of the discussion with PAC had to do with the gradual loss of funding in the parks. Councilmember Anglin noted that the city voters would be asked consider a parks millage again in 2013. The important part of the millage is not the wording of the millage, but the amendments that go with it (Policies for Administration).

COUNCILMEMBER RAPUNDALO

Councilmember Rapundalo reminded the public about a budget discussion that took place at City Council's last work session. Former Administrator Roger Fraser presented the 2012 budget to Council and at that time Councilmember Rapundalo asked what part of that budget could be mitigated in terms of delaying some of the layoffs proposed in the budget if health care settlements were reached with the unions. Councilmember Rapundalo stated that Mr. Fraser replied that in the case of

the firefighters and the Ann Arbor police officers, if they were on the same health care plan as the city's non-union employees, the cost savings would be able to pay for three or four full-time officers who are likely to be eliminated under the current proposed budget. On the Fire Department side, savings from that same health care plan would be sufficient to pay for more than two full-time firefighters. Councilmember Rapundalo encouraged more dialogue on this matter.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

Interim City Administrator Tom Crawford reported on the following:

PUBLIC SERVICES

- The AATA is looking to use the collective knowledge of the entire County to develop the Transit Master Plan. The community is encouraged to attend an upcoming community forum session, where residents can provide input and speak with a representative of the Master Plan team. The meeting in Ann Arbor will be held on Wednesday, May 11th from 6 to 8pm at the Downtown Ann Arbor District Library in the Multipurpose Room.
- The end of April has been full of precipitation events. The result is that the local soils are saturated and are not absorbing any more rainfall. This means in the current conditions when a rain event occurs, it all becomes runoff. Between 7am, Wednesday, April 27, and 7am on Thursday, April 29 about 2 inches of rain fell in the area.

The effects of the saturated soils are also being noticed in the sanitary sewer collection system. On Thursday morning, many of the trunk sewers were surcharging, running more than full. While the system passed this rain with few upsets, until there is a period of drier weather, the system is at risk of overflow during such events. It will take a period of a number of weeks with little or no rain to dry out the surrounding soils and reduce the risk to the sanitary system.

SYSTEMS PLANNING

- The Pedestrian and Bicycle Information Center has designated the City of Ann Arbor as a GOLD Level Walk Friendly Community for its walkability initiatives and programs. Sponsored by the U.S. DOT Federal Highway Administration and FedEx, Walk Friendly Communities is a national recognition program aimed at recognizing communities for their commitment to pedestrian safety. Ann Arbor is among only eleven communities recognized nationwide in the inaugural round of Walk Friendly Communities announced on April 26th. The Walk Friendly Community designation, awarded from bronze to platinum, is given to applicant communities that have demonstrated a commitment to improving and sustaining walkability and pedestrian safety through comprehensive programs, plans and policies. Ann Arbor is proud to receive the Gold.
- The Commuter Challenge is taking place again during the month of May. The City in cooperation with the DDA and AATA sponsors the getDowntown Program, who coordinates this event. In addition to supporting the getDowntown program, the City, as a downtown employer along with its employees, actively participates in the Commuter Challenge. - Saturday, May 7th is National Train Day, and the Michigan Association of Railroad Passengers will observe the day at the Ann Arbor Amtrak Station from 7 to 9

AM with donuts and coffee. They will celebrate with the passengers leaving on the westbound train scheduled to depart at 7:48 AM

- A free E-Waste Recycling Event is scheduled for Saturday, May 7th from 9 a.m. to 2 p.m. in the Pioneer High School parking lot, at 601 W. Stadium Boulevard (at Main Street). People can easily and securely dispose of working or broken electronic waste, such as computers, monitors, keyboards, mice, cables, televisions, VCRs. etc., in an environmentally friendly manner. The event is being co-sponsored by the U-M Office of Campus Sustainability and the Ann Arbor Public Schools. For more details, go to: http://sustainability.umich.edu/events.
- Another reminder that on Saturdays through May 28th, from 8 am until noon, City residents can receive up to 6 bushels of free compost or mulch, (self loaded), at the City's Compost Facility at 4150 Platt Road, compliments of the City's Compost Center operator, WeCare Organics. Residents will need to first stop at the Material Recovery Facility (MRF) Scalehouse with their water bill to verify that they are city residents, and they will receive a coupon for the free material. FARMERS MARKET

• Wednesdays are back at the Farmer's Market! After a long, cold winter the Farmer's Market is open Wednesdays, starting May 4, from 7 am – 3 pm.

In addition to the normal market hours, a new pilot is being planned to meet demand for increased hours at the Farmer's Market. The new pilot market would operate on Wednesday evenings from June to September from 4:30 pm to 8:30 pm.

CITY HALL CONSTRUCTION

- Larcom basement: All areas from the flooding dried well and no mold activity occurred. Radon levels have been tested and found to be below the action level for residential construction, 4 pCi/L [picocuries per liter]).
- Work on first floor interior grid ceilings and light fixtures is underway. Sprinkler piping is finished. Drywall finishing and painting continues. Larcom access has been shifted to the south entrance to the atrium and the remaining asbestos abatement on

the first floor has been completed.

- The sixth floor framing for interior walls is complete, as are sprinklers and exterior insulation installation. Drywall installation, finishing, and painting are occurring.
- In the new elevator tower, the two elevators are complete and have passed state inspection. The mechanical and electrical work in the elevator lobbies at the various floors is done, including fire protection. Grinding and polishing the floors is complete. The old elevators (west side of Larcom) are permanently out of service.
- The south side layout and excavation for site work is continuing. Construction of the new south stairway from the promenade deck to Huron St. has begun. The north side excavation for foundations and planters will begin soon.

Susan McGarry, 3rd Ward resident, encouraged Council to approve full funding for human services in the community.

Lucia Heinold, member of Interfaith Council for Peace and Justice, spoke in support of keeping funding for Ann Arbor Parks and asked that Council maintain the highest level of funding possible for human services.

Michael Apple, Avalon Housing, thanked Council for their support of Avalon Housing. Ellen Schulmeister, director of the Shelter Association of Washtenaw County (The Delonis Center), thanked Council for always supporting human services.

Nicole Eidelman, executive director of Interfaith Hospitality Network, asked that Council fully fund human services this budget year.

Julie Grand, chair of Park Advisory Commission, said that PAC passed two resolutions regarding their proposed budget. She expressed concerns about the proposed budget for the parks system not complying with the 2006 "fairness resolution."

Barbara May, executive director of Safehouse Center, said that Human Service funding is a necessary investment.

Diana Nearing, employee of Shelter Association of Washtenaw County, spoke in support of human services funding.

Pam Smith, executive director of Child Care Network, asked that Council continue to fund human services.

Lori Bush, director of the Family Support Programs at Child Care Network, spoke in support of funding human services.

Julie Steiner, Washtenaw Housing Alliance, asked that Council continue to fund human services.

Jean Carlberg, Washtenaw Housing Alliance, spoke in support of funding for human services programs.

A motion was made by Councilmember Briere, seconded by Councilmember Teall, that the Ordinance be amended as follows:

ZONING

(REGULATIONS CONCERNING THE MEDICAL USE OF MARIJUANA)

AN ORDINANCE TO ADD A NEW SECTION 5:50.1 TO CHAPTER 55 (ZONING) OF TITLE V OF THE CODE OF THE CITY OF ANN ARBOR REGARDING THE REGULATION OF THE MEDICAL USE OF MARIJUANA

5:50.1. Regulations Concerning Medical USE OF Marijuana

(1) Intent.

- (a) It is the intent of this section to provide appropriate locations AND REASONABLE RESTRICTIONS for the cultivation and transfer of [medical] marijuana allowed by the Michigan Medical Marihuana Act, MCL 333.26421 et seq. This is a unique land use with ramifications not addressed by more traditional zoning district and home occupation regulations. ALTHOUGH SOME SPECIFIC USES OF MEDICAL MARIJUANA ARE ALLOWED BY THE MICHIGAN MEDICAL MARIHUANA ACT, MARIJUANA CONTINUES TO BE CLASSIFIED AS A SCHEDULE 1 CONTROLLED SUBSTANCE UNDER FEDERAL LAW MAKING IT UNLAWFUL UNDER FEDERAL LAW TO USE, MANUFACTURE, DISTRIBUTE, OR DISPENSE, OR POSSESS WITH INTENT TO MANUFACTURE, DISTRIBUTE, OR DISPENSE MARIJUANA.
- (b) IT IS THE INTENT OF THIS SECTION TO PROTECT [Medical marijuana as a home occupation should not compromise] the health, safety, or AND GENERAL welfare of PERSONS AND PROPERTY [nearby residents] BY LIMITING LAND USES RELATED TO MEDICAL MARIJUANA TO DISTRICTS THAT ARE COMPATIBLE WITH SUCH USES. ADDITIONAL REGULATIONS IN THIS SECTION ARE INTENDED TO PROVIDE REASONABLE RESTRICTIONS WITHIN DISTRICTS SO THAT THESE USES DO NOT COMPROMISE THE HEALTH, SAFETY, AND GENERAL WELFARE OF PERSONS IN THE DISTRICT, OR OTHER USES ALLOWED IN EACH DISTRICT.
- (2) Definitions. The following words and phrases shall have the following definitions when used in this section.
- (a) WORD AND PHRASES CONTAINED IN THE MICHIGAN MEDICAL MARIHUANA ACT ("MMMA"), MCL 333.26421 ET SEQ. THIS SUBSECTION CONTAINS SOME WORDS AND PHRASES THAT ARE DEFINED IN THE MMA. AS USED IN THIS SECTION, THEY HAVE THE SAME MEANING AS PROVIDED IN THE MMMA, EXCEPT THAT IF AT ANY TIME THE DEFINITION OF A WORD OR PHRASE SET FORTH BELOW CONFLICTS WITH THE DEFINITION IN THE MMMA, THEN THE DEFINITION IN THE MMMA SHALL APPLY. THESE WORDS AND PHRASES ARE AS FOLLOWS:

- (i) "DEPARTMENT" MEANS THE STATE DEPARTMENT OF COMMUNITY HEALTH.
- (ii) "MARIJUANA" MEANS THAT TERM AS DEFINED IN SECTION 7106 OF THE PUBLIC HEALTH CODE, 1978 PA 368, MCL 333.7106.
- (iii) "MEDICAL USE" MEANS THE ACQUISITION, POSSESSION, CULTIVATION, MANUFACTURE, USE, INTERNAL POSSESSION, DELIVERY TRANSFER, OR TRANSPORTATION OF MARIHUANA OR PARAPHERNALIA RELATING TO THE ADMINISTRATION OF MARIJUANA TO TREAT OR ALLEVIATE A REGISTERED QUALIFYING PATIENT'S DEBILITATING MEDICAL CONDITION OR SYMPTOMS ASSOCIATED WITH THE DEBILITATING MEDICAL CONDITION.
- (iv) "PRIMARY CAREGIVER" MEANS A PERSON WHO IS AT LEAST 21 YEARS OLD AND WHO HAS AGREED TO ASSIST WITH A PATIENT'S MEDICAL USE OF MARIHUANA AND WHO HAS NEVER BEEN CONVICTED OF A FELONY INVOLVING ILLEGAL DRUGS.
- (v) "QUALIFYING PATIENT" MEANS A PERSON WHO HAS BEEN DIAGNOSED BY A PHYSICAL AS HAVING A DEBILITATING MEDICAL CONDITION.
- (b) OTHER WORDS AND PHRASES. THE WORDS AND PHRASE IN THIS SUBSECTION, AS USED IN THIS SECTION, SHALL HAVE THE FOLLOWING MEANINGS:
 - (i) "MARIJUANA" MEANS "MARIHUANA" AS USED IN THE MMMA.
- (ii) "MEDICAL MARIJUANA CULTIVATION FACILITY" MEANS BUILDING WHERE MARIJUANA PLANTS ARE BEING GROWN IN COMPLIANCE WITH THE MMMA, OTHER THAN AS A MEDICAL MARIJUANA HOME OCCUPATION.
- (iii) "MEDICAL MARIJUANA DISPENSARY" MEANS ONE OR MORE PRIMARY CAREGIVERS OPERATING WITH THE INTENT TO TRANSFER MARIJUANA BETWEEN PRIMARY CARE GIVERS AND/OR QUALIFYING PATIENTS FROM A LOCATION OTHER THAN A MEDICAL MARIJUANA HOME OCCUPATION.
- (iv) "MEDICAL MARIJUANA HOME OCCUPATION" MEANS AN ACCESSORY USE OF A NONRESIDENTIAL NATURE THAT IS CONDUCTED BY A REGISTERED PRIMARY CAREGIVER WHO RESIDES IN THE DWELLING AND (A) IS PERFORMED WITHIN A SINGLE-FAMILY DWELLING OR WITHIN AN ACCESSORY BUILDING TO THAT SINGLE-FAMILY DWELLING; (B) IS FOR THE PURPOSE OF ASSISTING ONE OR MORE REGISTERED QUALIFYING PATIENTS WHO DO NOT RESIDE IN THE DWELLING; AND (C) COMPLIES WITH THE MMMA.
- (v) "MICHIGAN MEDICAL MARIHUANA ACT" AND "MMMA" MEAN THE MICHIGAN MEDICAL MARIHUANA ACT, MCL 333.26421 ET SEQ.

DELETE:

- [a) Caregiver. A person who has agreed to assist with a patient's medical use of marijuana and has been issued a registry identification card and who otherwise meets the definition of a primary caregiver under the Michigan Medical Marihuana Act, MCL 333.26421 et seq.
- b) Medical marijuana. Marijuana (or marihuana) grown, used, or transferred for medical use as defined by the Michigan Medical Marihuana Act, MCL 333.26421 et seq.
- c) Medical marijuana cultivation. Growing marijuana as allowed by the

Michigan Medical Marihuana Act, MCL 333.26421 et seq.

- d) Medical marijuana cultivation facility. A single facility where more than 72 marijuana plants are being grown.
- e) Medical marijuana dispensary. One or more caregivers operating with the intent to transfer medical marijuana between caregivers and/or patients from a location other than a medical marijuana home occupation.
- f) Medical marijuana home occupation. An accessory use of a nonresidential nature involving medical marijuana which is performed within a single-family dwelling or within an accessory building to that single-family dwelling, and conducted by a caregiver or caregivers residing in the dwelling.
- g) Patient. A person who has been diagnosed by a physician as having a debilitating medical condition and has been issued a registry identification card and who otherwise meets the definition of qualifying patient under the Michigan Medical Marihuana Act, MCL 333.26421 et seq.
- h) Registry identification card. A document issued by the Michigan Department of Community Health that identifies a person as a registered qualifying patient or registered primary caregiver.] END OF DELETED TEXT.
- (3) Locations of medical marijuana dispensaries and MEDICAL MARIJUANA cultivation facilities. A medical marijuana dispensary or MEDICAL MARIJUANA cultivation facility may be located in the City only in accordance with the following restrictions:
- a) Medical marijuana dispensaries shall only be located in a district classified pursuant to this chapter as D, C, or M, or in PUD districts where retail is permitted in the supplemental regulations.
- b) Medical marijuana cultivation facilities shall only be located in a district classified pursuant to this chapter as C, M, RE, or ORL.
- c) In C districts, buildings used for MEDICAL MARIJUANA dispensaries or MEDICAL MARIJUANA cultivation facilities shall meet the minimum parking requirements of Chapter 59 for retail uses, with no exceptions for existing nonconforming parking.
- d) No medical marijuana dispensary or MEDICAL MARIJUANA cultivation facility shall be located within 100 feet of the parcel on which a public or private elementary or secondary school is located.
- (4) Medical marijuana dispensary and MEDICAL MARIJUANA cultivation facility regulations.
- a) No person shall reside in or permit any person to reside in a medical marijuana dispensary or MEDICAL MARIJUANA cultivation facility, except as allowed in the M1 and M2 zoning districts.
- b) No one under the age of 18 shall be allowed to enter a medical marijuana dispensary or MEDICAL MARIJUANA cultivation facility unless accompanied by a parent or guardian.
- c) No smoking, inhalation, or consumption of [medical] marijuana shall take place on the premises.
- d) In M1 and M2 districts, retail sales of products customarily incidental to the principal use shall be allowed provided that the total amount of internal

floor area of the structure devoted to sales and display of such products does not exceed 10 percent of the floor area of the total establishment.

- e) Drive-in medical marijuana dispensaries shall be prohibited.
- f) All activities of a medical marijuana dispensary or MEDICAL MARIJUANA cultivation facility shall be conducted indoors.
- g)No equipment or process shall be used in any medical marijuana dispensary or MEDICAL MARIJUANA cultivation facility which creates noise, dust, vibration, glare, fumes, odors or electrical interference detectable to the normal senses beyond the property boundary.
- h) AN ANNUAL ZONING COMPLIANCE PERMIT SIGNED BY THE OWNER SHALL BE REQUIRED, AND MUST BE RENEWED PRIOR TO THE ANNIVERSARY DATE OF THE ISSUANCE OF THE ORIGINAL PERMIT.
- I)[h] Medical marijuana dispensaries and MEDICAL MARIJUANA cultivation facilities shall comply with all other regulations of the zoning district in which the MEDICAL MARIJUANA dispensary or MEDICAL MARIJUANA cultivation facility is located, except when they are in conflict, in which case this section shall prevail.
- i)[j)] Medical marijuana dispensaries and MEDICAL MARIJUANA cultivation facilities shall be operated in compliance with [the provisions of the Michigan Department of Community Health and] the [Michigan Medical Marihuana Act MCL 333.26421 et seq] MMMA.
- (5) CULTIVATION OR OTHER MEDICAL USE OF MARIJUANA AS [Medical] MEDICAL marijuana home occupation [regulations] IN SINGLE FAMILY DWELLINGS.
- a) In a single family dwelling in any zoning district, no more than 72 [medical] marijuana plants shall be grown on the premises, regardless of the number of REGISTERED PRIMARY caregivers and/or REGISTERED QUALIFYING patients residing in the dwelling[, as a home occupation].
- b) The principal use of the SINGLE-FAMILY dwelling [unit] shall be [a dwelling]RESIDENTIAL OCCUPANCY and shall be in actual use as such.
- c) An annual zoning compliance permit signed by the owner shall be required, and must be renewed prior to the anniversary date of the issuance of the original permit.
- d) Total floor area devoted to THE medical marijuana [as a] home occupation in the principal or accessory building shall not exceed 25% of the gross floor area of the dwelling.

- h) A M[m]medical marijuana [as a] home occupation shall not generate more than 10 business-related vehicle trips in any one day in the vicinity of the MEDICAL MARIJUANA home occupation, and any need for parking generated by the conduct of such MEDICAL MARIJUANA home occupation shall be provided off-street in accordance with the off-street parking requirements.
- i) [No transfer of medical marijuana to patients other than those residing on the parcel shall occur on the parcel.]THE TRANSFER OF MARIJUANA FROM A PRIMARY CAREGIVER TO A QUALIFYING PATIENT SHALL NOT OCCUR ON THE LOT WHERE THE MEDICAL MARIJUANA HOME OCCUPATION IS

LOCATED.

- j) No equipment or process shall be used in such MEDICAL MARIJUANA home occupation which creates noise, dust, vibration, glare, fumes, odors or electrical interference detectable to the normal senses beyond the property boundary.
- k) Medical marijuana home occupations shall be operated in compliance with the provisions of [the Michigan Department of Community Health and] the [Michigan Medical Marihuana Act, MCL 333.26421 et seq]MMMA.
- (6) MEDICAL MARIJUANA HOME OCCUPATIONS ARE NOT PERMITTED IN MULTIPLE FAMILY DWELLINGS AND OTHER NON-SINGLE FAMILY DWELLINGS.
- ([6]7) [Medical] CULTIVATION OR OTHER MEDICAL USE OF marijuana in dwelling units [other than single family dwellings] WHEN THE USE IS NOT A MEDICAL MARIJUANA HOME OCCUPATION.
- a) In a dwelling unit [other than a single family dwelling] in any zoning district WHERE MEDICAL USE OF MARIJUANA IS NOT A MEDICAL MARIJUANA HOME OCCUPATION, no more than 12 plants for each REGISTERED QUALIFYING patient who resides in the dwelling unit shall be grown.
- b) The principal use of the dwelling unit shall be [a dwelling]RESIDENTIAL OCCUPANCY and shall be in actual use as such.
- [c) No transfer of medical marijuana to patients other than patients residing within the dwelling unit shall occur.]
- [d]C No equipment or process shall be used in cultivation which creates noise, dust, vibration, glare, fumes, odors or electrical interference detectable to the normal senses beyond the property boundary.
- [e]d) All aspects of THE medical USE OF marijuana shall comply at all times with the provisions of [the Michigan Department of Community Health and the Michigan Medical Marihuaua Act, MCL 333.26421 ET SEQ.]THE MMMA.
