*Mayor Hieftje called the meeting to order at 7:11 p.m. in the Ann Arbor Municipal Center, 2nd Floor Council Chambers, 301 E. Huron St.*

**APPROVAL OF AGENDA**

*Mayor Hieftje announced that the city budget may not be approved at tonight's meeting. Council will exercise its rights under the City Charter to recess the meeting and continue it on May 23, 2011. The mayor stated the City was still working with the Downtown Development Authority on a parking agreement and delays relating to this agreement were causing the necessity for the recess. Mayor Hieftje stated that the City Charter requires that Council pass a budget by the second meeting in May or the Administrator's proposed budget will be deemed approved. Mayor Hieftje stated this meeting would likely be recessed until Monday, May 23, 2011.*

**A motion was made by Councilmember Derezinski, seconded by Councilmember Taylor, that the Agenda be approved as presented. On a voice vote, the Mayor declared the motion carried.**

**1. Fred Veigel - Potential layoffs of Firefighters and Policemen with regard to the budget (DS-11)**

*Fred Veigel, 1612 W. Cross St. in Ypsilanti, MI, president of the Huron Valley Central Labor Council, AFL-CIO, spoke in opposition to the proposed layoffs of city firefighters and police officers. He expressed concerns about reducing public safety numbers below national standards.*

**2. Wesley Prater - Budget and Public Safety's Future (DS-11)**

*Wesley Prater, 8303 Warner, Saline, MI, Vice President of the Central Labor Council, spoke in opposition to the proposed budget cuts to public safety and asked that Council have more discussion on the budget prior to making any decisions.*

**3. Thomas Partridge - Recall Governor Snyder. Increased funding for human services and affordable housing critically needed. (DS-3, DS-7)**

*Thomas Partridge, Ann Arbor resident, addressed Council regarding recalling Governor Snyder and increasing funding for human services and affordable housing.*

**4. Chelsea Delrio - Firefighter Layoffs and Budget (DS-11)**

*Chelsea Delrio, 2253 Glencoe Hills Dr. #10, vice president of the Graduate Employees Organization, spoke in opposition to the proposed cuts to the Ann Arbor Fire Department.*

**5. James D-Amour - City Budget (DS-11)**

*James D'Amour, 2771 Maplewood Ave., expressed concern with the proposed city budget as it relates to park funding. He said he was concerned with declines in service and the cut in funding compared to other departments.*

**6. Lisa Dusseau - City Budget Proposed Firefighters Layoff (DS-11)**

*Lisa Dusseau, 2740 Lakehurst, spoke in opposition to the proposed layoffs in the Ann Arbor Fire Department.*

*Wendy Woods, 2034 Liberty Heights, expressed concern with the proposed cuts to the Ann Arbor Fire and Police Department personnel. She urged Council to take extra steps to bridge the gap between the Ann Arbor Fire Department and City Hall.*

**8. Stephen Ranzini - City Budget (DS-11)**

*Stephen Ranzini, 101 N. Main, #104, spoke in opposition to the proposed cuts to the Ann Arbor Fire and Police Departments.*

**9. Sue Maguire - Proposed Public Safety Cuts to Budget (DS-11)**

*Sue Maguire, 2119 Manchester, spoke in opposition to the proposed public safety cuts in the budget. She expressed concerns about closing another fire station.*

## **COMMUNICATIONS FROM COUNCIL**

### **COUNCILMEMBER RAPUNDALO**

*Councilmember Rapundalo commented on the status of negotiations with the Ann Arbor firefighters. He stated there is a misperception that the City refuses to meet with the firefighters for the purpose of negotiating a new contract. That information is not accurate. The City has met with the firefighters and their negotiating team at least 16 times, the most recent being approximately a week ago, and the negotiations are currently in arbitration at the firefighters' request.*

### **COUNCILMEMBER KUNSELMAN**

*Councilmember Kunselman updated Council and the public on a storm water issue at the Arbor Oaks subdivision. Councilmember Kunselman stated he and Councilmember Rapundalo contacted Paul Ganz, Regional Manager of DTE regarding the location of an electrical box near the storm water drainage. DTE crews were sent out to investigate and it was determined that everything was safe. DTE crew members will make visual changes to address issues that were raised by the neighbors.*

### **COUNCILMEMBER ANGLIN**

*Councilmember Anglin talked about the current budget process. He said that the budget for FY2011 includes a non-departmental contingency of \$639,000.00 allocated for overruns in the Justice Center construction. In the proposed FY2012 budget, there is another \$600,000.00 for asbestos abatement related to the Justice Center construction. Councilmember Anglin expressed concern about the overrun on the cost of the construction and that funds are being shifted to finish the project that is 50,000 square feet oversized. Councilmember Anglin stated that no additional monies should be budgeted for the project and that the building is already occupied in its current condition.*

### **MAYOR HIEFTJE**

*Mayor Hieftje updated the public regarding a fire services study that is ongoing in Ann Arbor. The study is being conducted by the ICMA, at the City's request. It is a comprehensive study of the City's fire services now and in the past, as well as a comparison with other communities. He asked Interim City Administrator Tom Crawford when the study would be complete.*

*Mr. Crawford said that he expects the study to be complete sometime in July 2011.*

*Mayor Hieftje clarified that at that time, if adjustments to the budget were needed as a result of the study, Council could amend the budget at any time after it is passed at the second meeting in May.*

*Mr. Crawford concurred that Council could amend the budget during the year at any time, if the situation changes.*

Mayor Hieftje asked Interim Administrator Crawford about a comment made by a speaker regarding \$103 million dollars in a rainy day fund.

Mr. Crawford said that the speaker was looking at the city's audit report. In the report, there are two different accounting standards that are used. He believed that the speaker was referring to the government-wide financial statements. That means all funds whether restricted or not, which include all of the water funds, sewer funds, etc., are all aggregated together and it's that fund balance that the speaker was referencing.

\*\*\*Council asked the city attorney to provide information regarding the transfer of funds from one fund to another. The city attorney was also asked to provide information regarding creating an ordinance to help fund human services.

With the increasing costs of driving, this year's challenge is an especially good time for all members of our community to explore alternative means of getting to work. ### W.A.T.S. COMPLETE STREETS PUBLIC MEETING

Complete Streets are facilities designed and provided to serve the needs of all users. This is part of the public participation process as WATS develops a countywide complete streets policy.

### PERMANENT FIRE CHIEF

Interim Administrator Crawford updated Council regarding the fire chief hiring process. Safety Services Administrator Barnett Jones has recommended that the City consider interviewing the two assistant fire chiefs and make an internal promotion. Chief Jones feels that both assistants are well qualified and should be considered for the position.
