# AIRPORT MANAGER REPORT

# C-1 Project Update - SRE Building/Environmental Assessment

*Mr.* Kulhanek gave updates on these two projects. The bonding company has hired a contractor to finish the work on the SRE and box hangars that was not completed by CMA. The contractor has already started work and hopes to have everything wrapped up this fall. The Airport is still waiting to hear back from the FAA regarding the EA. Inquiries have been made to the FAA regarding the status of the EA but have not been responded to. Member Sullivan asked that we look at vehicular parking at the south end of the taxilane between J and K rows as this area is congested. Perhaps installing no parking markings on the pavement would improve this.

# C-2 Crack Sealing Project

*Mr.* Kulhanek informed the Committee that we hope to undertake cracksealing in the NW T hangar area this fall. Airport tenants will be provided advance notification to minimize any inconveniences. Depending on the budget status next spring, additional areas of the airport may be addressed at that time.

# C-3 MDOT Pavement Inspection

MDOT will be conducting their pavement condition index assessment on September 28th. This assessment is done every five years and looks at all ramps, runways, taxiways and taxilanes. A report on the condition of our paved surfaces will be available later to direct our maintenance and repair efforts. In 2006, all of our paved surfaces were in good condition.

A number of comments and reviews have already been received. Comments are due back in mid-October so the final document can be made available for consideration by the Committee in November.

E-2 Request for Easement - Lohr/Textile Greenway Project

The Committee received and discussed the comments from the Washtenaw County Water Resources Commissioner and the Committee for Preserving Community Quality. Comments have not been received from Pittsfield Township. Member Tanner expressed a desire to clarify the question asked of the three parties and proposed working with the Airport Manager on specific language. No update from the FAA on the issues of impervious surface and pedestrian safety was received. This item of business will be continued to the next meeting.

# NEW BUSINESS

Airport Improvement Plan 2012-2022

*Mr.* Kulhanek reviewed the proposed Airport Improvement Plan(AIP) for 2012-2022. The AIP is a 10 year plan for projects and equipment that are eligible for grant funding. Many of these projects are shown on the Airport Layout Plan (ALP) though the documents are unrelated. The AIP is completed each year and submitted to MDOT-Aero for consideration and long term planning by the State and Federal aviation authorities. Each individual project on either the AIP or ALP needs specific project and funding approval by the City Council before the project can be started. The AIP was unaninously approved as presented.
