CALL TO ORDER

Mayor Hieftje called the meeting to order at 7:09 p.m. in the Guy C. Larcom, Jr. Building, 2nd Floor Council Chambers, 301 E. Huron St.

INT-2 Appointment of Judge Joseph F. Burke to 15th District Court

Judge Elizabeth Hines introduced the newest member of the 15th District Court, Judge Joseph F. Burke. Judge Burke was appointed by Governor Snyder last week to fill the vacancy created by Judge Creal. Judge Burke has practiced law in Ann Arbor for 30 years, serving in the Prosecutor's Office for a number of years, in civil practice for 6 years, and then back to the Prosecutor's Office when Brian Mackey invited him to work as Chief Assistant.

INT-1 <u>12-0256</u> GetDowntown Presentation - Nancy Shore

Mayor Hieftje introduced Nancy Shore of the getDowntown Program. She reported on some of the findings of the 2011 getDowntown Program Evaluation. Every two years, the getDowntown Program conducts a survey of downtown Ann Arbor Employers and Employees to; 1) Get a snapshot of the commuting habits of downtown Ann Arbor employees and 2) Gauge Employer and Employees attitudes, awareness and use of the getDowntown Program and of transportation options in general. > Thomas Partridge, Ann Arbor resident, addressed Council regarding priority concerns and issues, voting Democratic on February 28, 2012, protecting human rights before property rights, and funding affordable housing in Ann Arbor and neighboring townships.

2. Mary Kate Bachler - Ann Arbor Housing Commission Meeting Minutes (I-4)

Mary Kate Bachler, 1697 Cram Circle, addressed Council regarding the need for a warming center in the City of Ann Arbor. She also responded to comments made by the Mayor at the last Council meeting on the topic of the 100 units of affordable housing that was promised to the community by the City. She said that social change is only possible through taking a risk, and asked if Council would continue to provide scapegoats around the issue of homelessness in Washtenaw County or take a risk to promote real social change.

3. Mary Conway - Ann Arbor Downtown Development Authority Meeting Minutes (I-5)

Mary Conway, 312 W. Huron, addressed Council regarding the homeless in Ann Arbor. She said there is a body of employable people living at the Delonis Center. They are not all drug addicts or alcoholics, each of their stories are real and have had real impacts on their lives. The homeless are a part of Ann Arbor, she said, and they are a part of the ridership of the transit authority and should be included in surveys regarding the bus transit system.

4. TJ Rice - Housing Issues

TJ Rice, 100 N. Fourth Ave., Apt. 1001, addressed Council regarding homeless issues in Ann Arbor. He said that he has gotten involved with the Imagine Warming Centers recently and they held a meeting at the Library to discuss the project and progress thus far. They also met with the city administrator and looked at the property at 721 N. Main. He welcomed any help that Council could provide regarding a new warming center.

5. Bill Hanna - Engineering Advice

Bill Hanna, 2163 Ardenne Dr. addressed Council regarding changes that Council could make while conducting their business. He spoke about the process that took

place during the pedestrian crossing ordinance and the recent discuss regarding an idling ordinance. He asked that Council consider that these smaller incremental changes may be the way to approach change in the future. With incremental small changes, modifications could later be made as necessary.

COUNCILMEMBER HIGGINS

Councilmember Higgins said that there was no need for a Budget Work Session on Monday, February 27, 2012. She stated the next Work Session will be on Monday, March 12, 2012 and this session will include a presentation from the Fire Department.

COUNCILMEMBER BRIERE

Councilmember Briere spoke about a graffiti problem in the City. She stated many residents have complained to her about this issue as well. She urged property owners who are struggling with graffiti to clean up their property quickly to avoid more damage.

COUNCILMEMBER LUMM

Councilmember Lumm suggested that it is time to relook at the Pedestrian Crosswalk Ordinance. She stated there have been a number of accidents at crosswalks in the 2nd Ward.

COUNCILMEMBER ANGLIN

Councilmember Anglin spoke about the Fuller Road Station project and the possibility of using another site or the existing train station. Councilmember Anglin stated he would be bringing the topic up for discussion at the next Parks Advisory Commission meeting.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR

SNOWFALL ON FEBRUARY 21, 2012

City Administrator Steve Powers reported that crews were ready for the snow that fell today. However, he noted that the rate of one inch of snowfall per hour presented a challenge for them within the city limits. Crews will be out in the morning monitoring and preparing for what could be a re-freeze of city streets.
