C. Smith read the Resolution:

RESOLUTION TO RECOMMEND APPROVAL OF AN AMENDED AND RESTATED FIVE YEAR LEASE AGREEMENT WITH THE ANN ARBOR PUBLIC SCHOOLS FOR EBERBACH CULTURAL ARTS BUILDING

Whereas, The Eberbach Cultural Arts building at 1220 Wells Street is a City owned park facility;

Whereas, The Ann Arbor Public Schools (AAPS) uses the Eberbach Cultural Arts building for various cultural arts programming and has a desire to continue to have exclusive use of the building for continued cultural arts programming;

Whereas, The City and AAPS have partnered together successfully over the last 5 years under the terms of the expired lease agreement;

Whereas, The City and AAPS have developed an amended and restated lease agreement that will allow the AAPS to continue to use the facility for public recreational programming while having the AAPS cover the operating, maintenance and anticipated capital expenses associated with the building and grounds during the lease period;

RESOLVED, That the Park Advisory Commission recommend that City Council approve the five year amended and restated lease agreement between the City and Ann Arbor Public Schools for Eberbach Cultural Arts building.

Approved unanimously.

- C. Smith read the Resolution:

PARKS ADVISORY COMMISSION RESOLUTION RECOMMENDING TO THE CITY ADMINISTRATOR THAT CERTAIN PARKS BE DECLARED SMOKE FREE

Whereas on April 21, 2014 the Ann Arbor City Council passed ordinance 14-03 to add a New Chapter 64 to Title VI (Food and Health) of the Code of the City of Ann Arbor to limit smoking in outdoor public places (the "Ordinance");

Whereas the Ordinance provides that, among other things, the City Administrator may designate any City park or portion thereof as a smokefree outdoor public place in consultation with the Parks Advisory Commission ("PAC");

Whereas PAC, through a sub-committee and in consultation with City staff, examined the implementation of similar bans in other municipalities, consulted with a public health expert, and reviewed various methods of signage prohibiting smoking;

Whereas based on this work, PAC determined that City Parks with playgrounds and those within the Downtown Development Authority District should, in the first instance, be those where smoking is prohibited;

Now, therefore be it resolved that PAC:

- 1. Recommends to the City Administrator that, based on the above criteria, the parks on the attached list ('Exhibit A') be designated as "smokefree outdoor public places" under the Ordinance; and
- 2. That the City Administrator instruct Parks staff to: (i) post the appropriate signage as contemplated by the Ordinance; (ii) monitor both the effect and effectiveness of the ban as time and resources permit; (iii) report these findings to PAC one year after the implementation of the smokefree designations at which time PAC will consider whether it will recommend to the City Administrator that additional parks should be designated as "smokefree outdoor public places" under the Ordinance.

Approved unanimously.

J REPORTS FROM PARKS AND RECREATION MANAGER

C. Smith gave an update. Council voted to send the Fuller Lease resolution back to PAC for consideration to look further into the parking issues. Due back November 6. Senior Center has reopened with good improvements. Roof is yet to be replaced but no additional closures anticipated. Dog Swim had 512 dogs. Ice arena opened at Veterans Park. The indoor pool at Mack is open. 3-person scramble at LPGC and the Longest Hardest Day of Golf on 10/19. Burns Park concerts moving into renovated Senior Center so series can continue. Farmer's Market will host the AA Symphony Orchestra on 9/27. Petting instrument zoo for kids there, too. 10/8 at AADL downtown lecture on controlled burn program given by D. Borneman.
