City Council

City Council will meet in caucus the Sunday prior to each regular session at 7 p.m. in the Larcom Basement Conference room.

CALL TO ORDER

Mayor Taylor called the meeting of the Ann Arbor City Council to order at 7:01 p.m. in the Washtenaw County Administration Building, Board of Commissioners meeting room, 220 N. Main Street.

MOMENT OF SILENCE

Council stood for a moment of silence.

PLEDGE OF ALLEGIANCE

Mayor Taylor led Council in the recitation of the Pledge of Allegiance.

ROLL CALL OF COUNCIL

APPROVAL OF AGENDA

A motion was made by Councilmember Briere, seconded by Councilmember Lumm, that the Agenda be approved. On a voice vote, the Mayor declared the motion carried.

COMMUNICATIONS FROM THE CITY ADMINISTRATOR AC

City Administrator Steve Powers presented his written reports for information of Council and reported on the following:

Mr. Powers noted that the appointment of the City's new fire chief is on tonight's agenda. He stated a ceremonial swearing-in ceremony and welcoming will take place in early January.

Mr. Powers stated that Council has received the independent auditor's report. He stated the Audit Committee will meet with the City's auditors to review the report.

Mr. Powers stated that item B-1, the Main Street rezoning ordinance, has been revised. An updated copy has been provided in the Council's packet.

Mr. Powers reminded Council and the community that solid waste and recycling services would be delayed on Christmas Day and New Year's Day. He stated the usual Thursday collection would take place on Friday and Friday collection would take place on Saturday.

The City is providing four drop-off locations for undecorated Christmas trees from

December 15 through January 31. Locations include the parking lot adjacent to the drop-off station at 2950 E. Ellsworth, West Park parking lot, Gallup Boat launch parking lot, and the Olson Park parking lot.

- 1. Jim Mogensen Purchase of Police Body Worn Cameras (DC-6)

Jim Mogensen spoke about the Ann Arbor Police and the need for more transparency. He expressed some concern about the lack of openness in the past.

2. Lucia Heinold - Purchase of Police Body Worn Cameras (DC-6)

Lucia Heinold, 1224 Wines, spoke in support for the purchase of Police body-worn cameras. She expressed concern for the possibility of abuse.

3. Lloyd Shelton - Law Enforcement Strategies (DC-6)

Lloyd Shelton, City resident, spoke about a separate and unequal America. He urged the City Council to fire the police officer responsible for the shooting death of Aura Rosser.

4. Jeffery Harrold - Purchase of Police Body Worn Cameras (DC-6)

Rev. Jeffery Harrold, 1393 King George Blvd., spoke in support of the purchase of body-worn cameras for police officers. He stated more transparency and trust in police is needed.

5. Shirley Beckley - Purchase of Police Body Worn Cameras (DC-6)

Shirley Beckley asked that she be allowed to use her three minutes of speaking time for a moment of silence in recognition of Aura Rosser's three children.

6. Debra Kraus - Purchase of Police Body Worn Cameras (DC-6)

Not present.

7. Tom Partridge - Give Gift of Affordable Housing; Plan and Fund Affordable Housing (G-3, G-4)

Tom Partridge, City resident, urged Council to support policies and action to promote more affordable housing.

8. Gordon Smith - Camp Serenity

Gordon Smith, City resident, stated he is the founder of Camp Serenity. He stated the homeless are good neighbors on Burton Road, noting that the folks living there have cleaned up the area at their expense.

9. William Hampton - NAACP

William Hampton, President of local NAACP, spoke in support of the purchase of police body-worn cameras. He provided a letter of support for the purchase from the Ann Arbor NAACP. He urged the AAPD to be transparent and provide information regarding racial profiling within the Department.

10. Sheri Wander - Expand Shelter Services in Ann Arbor

Sheri Wander, member of non-profit Mission, spoke about the homeless camps in Ann Arbor. She stated the Mission group is a non-profit and is not endorsing or supporting the recall effort of Councilmember Kunselman. Not wearing her Mission hat, she spoke about the homeless situation and the importance of black lives.

CC COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER KAILASAPATHY

Councilmember Kailasapathy updated Council regarding the last Human Rights Commission meeting. She stated the Commission discussed the shooting of Aura Rosser by an Ann Arbor police officer and passed a resolution to move forward with the research into the creation of a civilian oversight body of the Police Department. She stated the Human Rights Commission understands that police cannot oversee police.

COUNCILMEMBER BRIERE

Councilmember Briere presented the application of Jason Frenzel to be appointed to the Environmental Commission. She stated she and Councilmember Anglin will support a resolution to make this appointment on January 5.

Councilmember Briere stated she and Councilmember Grand are the Council appointed liaisons to the City/School committee. She stated this committee is meeting next week with representatives from the Ann Arbor Schools and Steve Powers, City Administrator.

Councilmember Briere thanked the public for their activism on the police shooting incident, stating that Ann Arbor has never been a complacent community. She stated she looks forward to the independent report on the incident.

COUNCILMEMBER GRAND

Councilmember Grand stated she is presenting a resolution to Council to reappoint Shannon Brines to the Greenbelt Advisory Commission. The resolution will be brought to Council for approval on January 5, she stated.

Councilmember Grand stated she is hosting office hours again for her constituents. Her next open office hours will be at Bryant Community Center on Tuesday at 9 a.m.

Councilmember Grand also thanked the public speakers who came out to speak regarding the police shooting incident and the proposed purchase of body-worn cameras.

COUNCILMEMBER WARPEHOSKI

Councilmember Warpehoski thanked the public who came out tonight to speak about the Aura Rosser shooting and the issue of police body cameras. He stated the formal City Council meeting is not the best forum for dialogue and suggested that another public meeting may be necessary. He stated he recognizes that the issue of racial inequality in policing is coming to light and needs to be discussed. Regarding the concerns of Mr. Shelton, who spoke this evening, Councilmember Warpehoski stated he cannot support the firing of the Ann Arbor police officer until the investigation has been completed.

Councilmember Warpehoski stated there will be a Capstone presentation by UM graduate students tomorrow at the Downtown Library at 4 p.m. regarding the Allen Creek Greenway. He urged those interested to attend.

COUNCILMEMBER KUNSELMAN

Councilmember Kunselman addressed concerns expressed regarding his previous comments about the Burton Road homeless camp and his position regarding the homeless population and the City's support of the shelter, noting that he and the Council as a body, recently approved additional funding to the Delonis Center on November 17. Councilmember Kunselman read the following Whereas clauses from that resolution:

Whereas, The local sheltering system was stretched beyond capacity to accommodate the overwhelming demand for safe, warm space during the near-constant emergency weather conditions:

Whereas, The Office of Community & Economic Development - on behalf of the City of Ann Arbor, Washtenaw County, and the local Continuum of Care Board - and the Washtenaw Housing Alliance convened a Winter Emergency Shelter/Warming Center Response work group in the fall of 2014;

Whereas, The workgroup proceeded to review the scope of the problem, surface and evaluate a set of possible solutions, and explore a variety of community partnerships and funding sources;

Whereas; The recommendations include funding the Shelter Association of Washtenaw County to support up to 50 additional spaces in a rotating, overnight warming center for the months of January 2015 to March 2015 to be housed in three local churches each hosting one month;

Whereas, The recommendations also include funding the Shelter Association of Washtenaw County to support a consistent, daytime warming center from November 2014 through March 2015 to be housed in its Delonis Center unless local churches are identified to host the daytime warming center as well;

Whereas, The recommendations also include funding Community Support & Treatment Services to support a 10% increase in funding available for emergency hotel and motel vouchers for the most vulnerable homeless residents on extreme weather days;

Whereas, These recommendations in total will cost no more than \$178,636.00;...

Councilmember Kunselman also read a letter from Ellen Schulmeister, Delonis Shelter Director, that was written to Ryan Stanton of MLive, regarding the capacity of the Delonis Shelter and a rebuttal to comments made by public speakers. Ms. Schulmeister's letter clarified that the shelter does not see the same folks at the warming shelter every single night and the numbers vary daily, making a number for capacity difficult to quantify. Her letter stated that support staff from CSTS check on known homeless camps and provide service, including providing hotel rooms in some cases. Councilmember Kunselman read that Ms. Schulmeister's letter stated that she answered affirmatively to Councilmember Kunselman's question as to whether the shelter could serve the needs of the campers, planning for 100 beds this winter.

COUNCILMEMBER EATON

Councilmember Eaton addressed the comments made against Councilmember Kunselman. He stated he supports Councilmember Kunselman and noted the speakers are misrepresenting him. Councilmember Eaton stated the homeless are setting up a camp on private property.

Councilmember Eaton thanked Councilmember Kailasapathy for her work on the Human Rights Commission.

COUNCILMEMBER LUMM

Councilmember Lumm thanked the Mayor for his compassion during a very difficult situation. She concurred with Councilmember Eaton's remarks as well.

Councilmember Lumm reported on the recent deer management public meeting. She stated it was very well attended, with 75 residents signing in. A website on the issue has been created at www.wc4eb.org.

COUNCILMEMBER BRIERE

Councilmember Briere reported out regarding the recent public meeting on the Nixon/DhuVarren/Green Road intersection. She stated there are two main concerns that were raised at the meeting: traffic studies were performed by the developers; and the studies did not extend far enough beyond the intersection.
