C-1 14-0049 2014 Calendar

Regular Meeting Schedule for the Greenbelt Advisory Commission

C-2 Staff Presentation on Preserve Washtenaw

Ginny Trocchio gave a presentation describing the function and history of the Preserve Washtenaw Group. She stated that Preserve Washtenaw is an advisory group formed in 2005. The group serves as a coordinating body for public and private land conservation within Washtenaw County. Its members include City of Ann Arbor Greenbelt, Washtenaw County, Scio, Ann Arbor and Webster Townships. All of the members of the group have passed a millage for land preservation. The idea behind forming Preserve Washtenaw was to have the group meet periodically to discuss projects and to collaborate and coordinate efforts to ensure the overall goal of land preservation.

Commissioner Brines asked who typically attends the Preserve Washtenaw Meetings. Ms. Trocchio responded that she usually represents Greenbelt but she would be happy to keep the Commission apprised of upcoming meetings.

Commissioner Buttrey asked if the Preserve Washtenaw group was the only forum that information is exchanged. Ms. Trocchio responded saying she communicates with some of the members on specific deals on a more regular basis. However, it is a forum for a member from each area to meet regularly.

C-3 STAFF UPDATE

Ginny Trocchio stated she has not heard from FRPP regarding the 2014 Farm and Ranch Protection Grants. She noted that typically the grants are announced in March of each year. She stated that she would keep the Commission informed of any information she receives regarding the grants.

Ms. Trocchio informed the Commission that there is still work being done on the registry program. She informed the Commission that she has met with the City Attorney's office and the City Administrator regarding the matter. Lastly, she stated a database of approximately 250 landowners had been compiled. She plans to contact those landowners and provide information regarding the registry program in the next few weeks.
