Tarek Joseph, 2860 Lakehurst Lane, spoke in opposition, citing quality of life issues. John Palmer, 2870 Lakehurst Lane, expressed concerns about the environment. Jane Klingsten, 3347 Elsinore, questioned whether the City's Police and Fire Departments could handle the increase in population from this development, stating public safety is a concern.

A new resident in the area spoke about wetland mitigation and the need to consider the entire ecosystem.

Lakshmi Raman, 2378 Hickory Point Dr., urged Councilmembers to visit the Nixon/Green/Dhu Varren intersection during rush hour before making a decision. Jim Liu, 2380 Foxway, expressed concerns about the impacts to the current traffic problems in the area.

The following people spoke in opposition to a deer cull:

An unknown speaker spoke in opposition to an organized deer cull in Ann Arbor, stating the only humane option is non-lethal birth control.
Jim Ringold, Ward 1, spoke in support of non-lethal methods.
Sharon Rothwell, Chair, Humane Society of Huron Valley, urged Council to make a decision based on facts. She suggested the City consider hiring an animal control officer again.
Mary Hinker, 2989 Hickory Lane, spoke in support of non-lethal methods.
An unknown resident stated more development is pushing the deer population into smaller and smaller areas.
Jeff Hayner, 1807 Pontiac Trail
Shunah Sii Rose, Ward 1, stated there was not enough time for public input.
Jane Glass, Ward 3, stated she did not want firearms used in her neighborhood.
Lakshmi Raman, Ward 1, expressed concern about more development adding to the deer problem.

Dorothy Yenni, 1165 Wendy Court, stated a deer cull is not effective.
Nancy Hanke, Ward 3, spoke in opposition to a cull, and urged Council to manage the deer humanely. Valerie Benka, Ward 4
Jennifer Martin, 3300 E. Dobson, member of the Humane Society Huron Valley Board

Eileen Benson, new City resident Mary Richter, Ward 4, stated more information should be provided and the decision should not be made in the summer. Susan Cornfield. Matthai Farms Ed Vielmetti, Ward 4, urged Council to spend \$90,000 elsewhere. An unknown resident expressed concerns about the cost of a deer management program. A Ward 2 resident stated the deer population is not high enough to warrant a cull. Tanya Hilgendorf, Executive Director of the Humane Society of Huron Valley Jaime Magiera, Ward 4, urged Council to table the issue until more study could be conducted. Karen Patterson, Director of Education, Humane Society of Huron Valley, spoke about animal rights. Bonnie Flanders, Ward 4, stated she is opposed to the use of guns in town. Susan Carr, resident, urged Council to consider non-lethal methods. Freda Herseth, 1508 Long Shore Drive, spoke in opposition to gun use in the City. Greg Hebert, 2058 Ascot, spoke in opposition to the use of guns in the City. Kate Murphy, Livingston County resident Robert McGee, 2245 Placid Way, representing Ann Arbor Residents for Non-Lethal Deer Management, spoke about his recent petition drive to amend the City Charter and stated more than 70% of the residents he spoke with were opposed to a cull. A former resident of Rochester Hills, Michigan The following people spoke in support of a deer management program that includes a cull: Margaret Leary, 1056 Newport, stated a cull is more humane than non-lethal methods. Bernie Banet, Heather Way, speaking for the Washtenaw Citizens for Ecological Balance, stated there are too many deer in Ward 2. Drew Youngedyke, Ward 4, spoke in support of a cull, stating the protein would be local and organic food for the homeless. He stated he is opposed to adding hormones to the food source. Dana Muir, 815 Green Road, spoke in support of a cull and stated it is time to make a decision. Hillarv Handwerger. 3535 Sturbridge Court Kurt Sonen, Ward 2, urged Council to base decision on science, not emotions. Paul Hysen, 820 Watershed, spoke in support of a cull and stated Lyme Disease is a problem in Michigan. Robert Sims, 2107 Devonshire, spoke in support of cull. An unknown resident living near Washtenaw Avenue Judy Cohen, 2855 Heather Way, stated there are too many deer in her neighborhood and Lyme Disease is a concern. Linda Levy, Burns Park A Ward 2 resident A resident of Watershed Drive An unknown speaker urged Council to approve the cull and begin next winter.
