1. Diane Giannola - Library Lot Development Rights

Diane Giannola, 3252 Alpine, spoke about the redevelopment of the Library Lot, stating the silent majority of Ann Arbor understood that a tax-generating building would be built on this site. She urged Council to proceed, stating a park is not feasible, and she noted the problems of Liberty Plaza.

2. Lisa Abrams - Deer Cull

Lisa Abrams, 2745 Ember Way, stated she is part of an organization called FAWN, clarifying that she is not part of the recall effort of Councilmember Westphal, but that her group is requesting a moratorium on the deer cull.

3. Jennifer Robertson - Deer Cull

Jennifer Robertson, 1310 Glendaloch, spoke in support of a moratorium of the approved deer cull.

4. Grant Strobl - Introduction as Government Relations for U of M Central Student Government

Grant Strobl, 1928 Geddes, introduced himself as the new government liaison for the Michigan Student Assembly. He welcomed Councilmembers to reach out to him regarding student issues.

5. Alan Haber - Library Lot

Alan Haber, 531 Third Street, spoke about his citizen-initiated petition to create a Community Commons on the Library lot. He urged Council to listen to the public.

6. Kyle Lady - Council Committees (DC-2)

Kyle Lady, member of the Taxicab Board, expressed concern about the 2016 Council Committee assignments and the fact that a Council Member was not being assigned to the Taxicab Board.

7. Michael Benson - Council Committees (DC-2)

Michael Benson, Chair of the Taxicab Board, spoke about the 2016 Council Committee Assignments and urged Council to include a Council Member appointment to the Taxicab Board. Mr. Benson stated the taxicab industry is changing and the Board is at a crossroads; he stated a Council representative was needed to make recommendations regarding future direction.

Councilmember Kailasapathy stated the Human Rights Commission was holding a public hearing regarding the possible creation of a civilian Police Oversight Board. The hearing is scheduled for Wednesday, December 9 at 6pm in Council Chambers and will be televised.

Councilmember Lumm stated there is a neighborhood meeting scheduled regarding the proposed Nixon North and South developments on Wednesday, December 9 from 6:30 to 8:30pm at Huron High School. She encouraged all members of the public to attend.

Councilmember Grand stated she looks forward to the Council Rules discussion and proposed changes that would allow for a more efficient use of the Consent Agenda, including the elimination of a dollar threshold. Councilmember Grand also spoke about DC-8, funding for bicycle lights, and apologized to Council for the late addition.

• When the first or third Monday precedes an election day, in which case it will be held on Thursday of that week.

• When Council Chambers at City Hall are unavailable due to construction or other reasons, Council Meetings shall be re-located to another suitable location.

• For the purpose of this rule, major holiday shall be defined as:

any civic holiday observed by the City of Ann Arbor, or

• any major religious holiday observed by more than 2.5% of Ann Arbor residents (as reported on City-Data.com or other appropriate survey) and that precludes civic participation from adherents.

• Council shall also avoid scheduling work sessions on major holidays and, when possible, avoid scheduling special sessions on major holidays.

• For the 2016 calendar year, the religious holidays recognized for rescheduling shall include:

• The first and second nights of Passover

• The evening before and the first night of Eid al-Fitr (as determined by the Fiqh Council of North America and reported on moonsighting.com)

• The evening of the first night of Rosh Hashanah, the first 2 days of Rosh Hashanah, and the evening following the second day*,

 \circ $\,$ The evening of Yom Kippur, the day of Yom Kippur, and the evening following the day of Yom Kippur

Council may, by majority vote, adjust the schedule of regular meeting times and places to accommodate special elections, construction, or other external contingencies that were unanticipated when the calendar was initially set.
