Rosalind Wares spoke in opposition to any park closures, stating the closure of so many parks all winter was not acceptable.

2. Andy Poli - Deer Cull (DC-2)

Andy Poli, 2111 Tibbits Court, spoke in opposition to the approved deer cull, urging Council to find a more intelligent solution.

3. Mirmala Hanke - Deer Cull (DC-2)

Mirmala Hanke urged Council to cancel the contract with the USDA and to work with the Humane Society on a humane solution.

4. Nancy Witter - Deer Cull (DC-2)

Nancy Witter, 235 Brookside, thanked Mayor Taylor for his vote against the deer cull and urged Council to reconsider the closure of City parks for the cull.

Shunah Sii Rose - Access to City Parks (DC-2)

Shunah Sii Rose, 2697 Arrowwood Trail, spoke in opposition to any park closures, stating these closures will affect the lives of many Ann Arbor residents.

6. Sarah Byers - Deer Cull (DC-2)

Sarah Byers, 1308 Traver, spoke in opposition to the deer cull and the closing of parks. She asked Council questions regarding other possible solutions.

7. David Silkworth - Deer Cull (DC-2)

David Silkworth, 2048 Charlton, Ward 5, spoke in opposition to the deer cull and the closing of City parks. He also objected to the targeting of pregnant deer.

8. Karen Freedland - Deer Cull (DC-2)

City's biodiversity and the environment. He thanked Councilmember Warpehoski for his blog and stated he concurred with his comments.
