Resolution to Recommend Approval of a Contract with Saladino Construction Company, Inc. to Provide Barrier Free Access to the Bandemer Park Rowing Docks for \$68,734.00 and Appropriate Funds

A. Kuras gave background on providing barrier free access to the rowing docks.

The Resolution reads:

RESOLUTION TO RECOMMEND APPROVAL OF A CONTRACT WITH SALADINO CONSTRUCTION CO. INC. TO PROVIDE BARRIER FREE ACCESS TO THE BANDEMER PARK ROWING DOCKS FOR \$68,734.00 AND APPROPRIATE FUNDS

Whereas, the Bandemer rowing facility dock is not currently barrier free;

Whereas, The Parks and Recreation Open Space Plan recommends improvements to existing facilities to facilitate barrier free access;

Whereas, Competitive bids were sought to provide barrier free access to the existing docks, including parking, an accessible pathway and ramp;

Whereas, Funding for improvements to Bandemer Park is available in the Bandemer Park Fund fund balance:

Whereas, Competitive bids were received by Purchasing on July 9, 2015; and

Whereas, Saladino Construction Company, Inc. submitted the lowest responsive bid;

RESOLVED, That the Park Advisory Commission recommends authorizing the appropriation of \$75,607.00 from the unobligated fund balance in the Bandemer Park Fund to fund the contract budget and construction contingency; and

RESOLVED, That the Park Advisory Commission recommend approval of a contract with Saladino Construction Company, Inc. for \$68,734.00 to provide barrier free access to the existing rowing docks, and approve a construction contingency of \$6,873.00 (10%) to cover potential contract change orders for a total contract amount of \$75,607.00 for the life of the project without regard to fiscal year.

The Resolution reads:

Whereas, On May 19, 2015, the Park Advisory Commission approved the

'Recommendations and Guidelines for Dog Park Site Selection, Design, Operations and Maintenance' document;

Whereas, The documents outlines a process to establish new dog park sites, with the first recommendation being to establish an ad-hoc committee comprised of members from the Park Advisory Commission, staff and citizens; and

Whereas, community members submitted their names and interest in becoming a member of the committee and the Park Advisory Commission Dog Park Subcommittee chose 6 members:

RESOLVED, That the Park Advisory Commission establish the ad-hoc committee to identify potential sites and be involved in the process to establish dog parks; and

RESOLVED, That the ad-hoc dog park committee shall advise the City Parks & Recreation Services Unit and the City Park Advisory Commission on the following:

- a. Identify potential dog park sites using established criteria
- b. Evaluate sites using placement criteria
- c. Narrow sites to those that score the highest
- d. Develop a concept plan showing proposed location
- e. Plan for public meeting
- f. Vote on proposed sites

RESOLUTION TO RECOMMEND APPROVAL OF A PARTNERSHIP AGREEMENT WITH THE MICHIGAN RECREATION AND PARK ASSOCIATION, ACCEPT A

#### GRANT FOR \$38,000.00 AND APPROPRIATE FUNDS

Whereas, the Michigan Recreation and Parks Association is one of only a handful of agencies in the State of Michigan that was awarded funding from the newly established Michigan Health Endowment Fund;

Whereas, The MRPA is seeking agencies interested in participating as a pilot program;

Whereas, Participation by the City in this program will highlight the role that Ann Arbor's parks play in the health and well being of our community members;

Whereas, Programs funded through this grant will include senior fitness classes, enhanced offerings for scholarship recipients, and highlight our existing teen camp,

RESOLVED, That the Park Advisory Commission recommend the City Council accept and appropriate funding for \$38,000.00 from the Michigan Recreation and Parks Association.
