**CALL TO ORDER**

*Mayor Taylor called the Special Work Session of the Ann Arbor City Council to order at 7:00 p.m. in the Guy C. Larcom, Jr. Building, 2nd Floor Council Chambers, 301 E. Huron Street.*

**Deer Management**

*Sumedh Bahl, Community Services Area Administrator, presented the outcome of the City's deer management survey and study. Numerous public meetings were held and a survey via A2 Open City Hall was conducted.*

*Mr. Bahl discussed management options, including a deer cull in Wards 1 and 2, a citywide deer feeding ban (through a new ordinance), and annual flyover surveys.*

*Stephanie Boyles Griffin of the Humane Society of the United States spoke about non-lethal deer management options, including sterilization. The Humane Society endorses the use of PZP protein to create a vaccination against fertilization of female deer. It is reversible, she noted, lasting only two to three years.*

*Ms. Boyles Griffin also discussed surgical sterilization, an invasive permanent procedure. The procedure removes a doe's ovaries, similar to a cat or dog spay.*

*Councilmember Kunselman requested additional references from the Humane Society regarding previous sterilization projects.*

*A representative from the MDNR was present to answer questions.*

*Aaron Blackford, of Aaron's Nuisance Animal Control, spoke about the process of setting up a deer cull and some of his experiences, including his work in the Village of Barton Hills, City of Jackson, Michigan and the University of Michigan Dearborn*

*campus. Mr. Blackford noted that a cull is not a deer hunt. He stated that his team follows the MDNR rules for conducting a cull.*

**PUBLIC COMMENT - GENERAL (3 MINUTES EACH)**

*A Fifth Ward resident stated she would like Council to consider all the wards in the City when discussing deer management options, not just the First and Second Wards.*

*An unidentified resident spoke about a deer cull and the projected growth rate and the "break even" point.*

*Kai Petainen, City resident, questioned the motivation of the Humane Society of the United States, stating they have a multi-million dollar budget and will benefit from a sterilization effort. He stated if Council authorizes sterilization, the Humane Society should pay for the project in full.*

*A Ward Two resident spoke about the deer population and urged Council to begin a deer cull this winter. She stated ticks and Lyme Disease are now a concern.*

*Paul Hyson, 820 Watershed, spoke in support of a deer cull. He expressed concern about the policies and practices of the Humane Society.*

*Margaret Leary, 1056 Newport Road, urged Council to accept the recommendation in the staff report to do a deer cull. She expressed concern about Lyme Disease.*

*Chris Graham, 925 Aberdeen, spoke about the destruction caused by deer and the damage to property.*

*Nancy Stoll, 1314 Broadway, spoke in support of a lethal deer cull.*

*Hillary Handwerger, Glacier Highlands, spoke about the destruction caused by deer.*

*Lisa Weston-Abrams, Ward Three, urged Council to consider humane efforts. She spoke in support of the Humane Society's approach.*

*A Ward Two resident and member of Washtenaw Citizens for Ecological Balance, spoke in support of a deer cull.*

*Bernie Banet, Ward Two resident, spoke in support of a cull.*

*Toni Spears, metro parks volunteer, stated deer management has already been taking place in the parks for a decade. She stated the parks have used culls safely for years.*

*Cynthia Greene spoke about a car accident with a deer.*

*A Ward Two resident spoke about the damage caused by deer and urged Council to support a cull.*

*Judy Comb, Second Ward, spoke about the concerns of Lyme Disease and urged Council to support a cull.*

*A Ward Two resident spoke in support of non-lethal management of deer. She urged Council to be progressive on this issue.*

*An unknown resident spoke in support of non-lethal management of deer.*

*A Ward One resident thanked Council for engaging the Humane Society. She encouraged Council to consider non-lethal methods.*

*Robert McGee, of the Residents for Non-Lethal Management of Deer, spoke in opposition to a cull. He stated shooting within 450 feet of residential homes is dangerous, noting the mistaken shooting of a rare albino buck in the metro parks during a recent organized cull.*

*Terri Schneider, First Ward resident, spoke in support of non-lethal methods of deer management. She also corrected some myths about Lyme Disease.*
