G1 <u>16-0742</u> Resolution to Recommend Approval of a Michigan Department of Natural

Resources Trust Fund (MNRTF) Grant Development Project Agreement for Gallup Park Universal Access Playground and Site Renovations and

Accept and Appropriate up to \$300,000.00 in Funding

C. Smith gave the history of this resolution. Resolution brought to PAC to submit a grant, the grant was received, and this resolution is to accept the monies from the state for this project. We applied for \$300K and received \$300 from this very competitive grant. A. Kuras gave more information and timing of this project.

A. Kuras provided additional details regarding the site improvements.

Resolution reads as follows:

Whereas, The Michigan Department of Natural Resources approved a matching grant through the Michigan Department of Natural Resources Trust Fund (MNRTF) or (DEPARTMENT) for construction of Gallup Park Universal Access Playground and Site improvements,

Whereas, the Park Advisory Commission recommended approved the grant application on February 24, 2015, and City Council recommended approval of the grant application on March 16, 2015, and

Whereas, Local match funding for the project includes \$350,000.000 from the Rotary Club of Ann Arbor and \$150,000.00 from the Parks Maintenance and Capital Improvements Millage;

RESOLVED, That the Park Advisory Commission recommend City Council accept the terms of the Agreement as received from the Michigan Department of Natural Resources, and that the City of Ann Arbor does specifically agree, but not by way of limitation, as follows:

- 1. To appropriate all funds necessary to complete the project during the project period and to provide Five Hundred Thousand dollars to match the grant authorized by the DEPARTMENT.
- 2. To maintain satisfactory financial accounts, documents, and records to make them available to the DEPARTMENT for auditing at reasonable times.
- 3. To construct the project and provide such funds, services, and materials as may be necessary to satisfy the terms of said Agreement.
- 4. To regulate the use of the facility constructed and reserved under this Agreement to assure the use thereof by the public on equal and reasonable terms.
- 5. To comply with any and all terms of said Agreement including all terms not specifically set forth in the foregoing portions of this Resolution.

RESOLVED, That the Park Advisory Commission recommend Mayor and Council accept and appropriate funding not to exceed \$300,000.00 from the DEPARTMENT; and

RESOLVED, that the Park Advisory Commission recommend City Council approve the project agreement between the City and the Michigan Department of Natural Resources for the construction of the Gallup Park Universal Access Playground and Site Improvements.

#### **G2** 16-0743

Resolution to Recommend Approval of a Contract Agreement with the Michigan Department of Transportation for the Border to Border Trail Reconstruction - Gallup Park Segment, Contract #16-5187 (\$699,100.00)

C. Smith says this grant was received \$447,537 which will replace the BTB Trail between Geddes Dam and the picnic shelters in Gallup Park. MDOT TAP projects control the bidding for this.

The resolution reads as follows:

Whereas, The City was awarded a grant from the Transportation Alternatives Program to reconstruct the Border to Border Trail in Gallup Park from the parking lot west of Huron Parkway to Dixboro Road;

Whereas, Funding for the City share of the project is available from the approved Park Maintenance and Capital Improvements Millage FY 2016 budget; and

Whereas, It is necessary to approve the cost sharing agreement with the Michigan Department of Transportation so that the project can proceed;

RESOLVED, That the Park Advisory Commission recommend City Council approve a contract agreement with MDOT for the Border to Border Trail Reconstruction, Gallup Park Segment (\$699,100.00)

## **G3** 16-0761

Resolution to Recommend Accepting a Fair Food Network Grant for the Ann Arbor Farmers Market for \$50,000.00 and Appropriate Funds

C. Smith shared the history on this resolution.

The resolution reads as follows:

Whereas, Double Up Food Bucks is a national project providing incentives to encourage healthier food choices for food stamp (SNAP) recipients, directly benefitting low-income families and local farmers in Michigan and working to impact future food and nutrition policy, and

Whereas, the City of Ann Arbor has received grant funding from the Fair Food Network since 2010 to administer the Double Up Food Bucks program at the Ann Arbor Farmers Market,

RESOLVED, That the Park Advisory Commission recommend approving a grant agreement with the Fair Food Network to administer the Double Up Food Bucks program at the Ann Arbor Farmers Market; and

RESOLVED, That the Park Advisory Commission recommend City Council accept and appropriate funding in the amount of \$50,000.00 from the Fair Food Network

establishing a grant revenue and expenditure budget in the Major Grants fund for the DUFB program without regard to fiscal year.

Resolution to Recommend Approval of a Contract with Blue Star, Inc. for Property Demolition, Clean Up and Site Restoration at 3013 Huron River Drive (\$93,300.00)

C. Smith gave a history on this resolution.

Resolution reads as follows:

Whereas, The City acquired property at 3013 Huron River Drive through a donation to be used as parkland;

Whereas, The property contains structures and debris that need to be removed prior to allowing public access;

Whereas, The property donation included a fund for maintenance and upkeep of the property which will be used to complete this work;

Whereas, The project was bid a year ago, and the contractor failed to commence the work:

Whereas, The project was rebid, and Blue Star, Inc. submitted the lowest responsible bid to provide the demolition and restoration services;

RESOLVED, That the Park Advisory Commission recommend City Council approve a contract with Blue Star, Inc. to demolish the structures, clean and restore the site, and approve a construction contingency of \$9,330.00 (10%) to cover potential contract change orders for a total contract amount of \$102,630.00 for the life of the project without regard to fiscal year.

Resolution to Recommend the Parks Operating Budget Cover FY2016 Operating Expenses at the Ann Arbor Skatepark

C. Smith said this is an annual resolution and this is part of the operational agreement.

Resolution reads as follows:

Whereas, The agreement between the Friends of the Ann Arbor Skatepark (Friends) and the City of Ann Arbor (City) states the funding of the operation and maintenance of the Ann Arbor Skatepark is the responsibility of the Friends;

Whereas, The agreement provides a provision whereby the City can contribute to the cost of annual maintenance and operation as part of a funding review process;

Whereas, In FY2016, as of May 9th 2016 approximately \$3,000.00 in operational costs have been expended at the Skatepark and the City parks overall operating budget is

able to absorb these expenses without neglecting other budgeted park needs;

RESOLVED, That the Park Advisory Commission recommend that the parks operating budget cover FY2016 operating expenses at the Ann Arbor Skatepark.
