II APPROVAL OF AGENDA

A. Stroud made a motion to approve the agenda, seconded by L. Keeler. All approved on a voice vote.

III APPROVAL OF JUNE 15 MEETING MINUTES

S. Petersen had one correction to the announcement section. H. Koch had recorded that the event that A. Schnitzer discussed took place in November, but it takes place annually in October.

L. Keeler made a motion to approve as amended, seconded by Z. Damon. All approved as amended on a voice vote.

b AAPD Chief James Baird - Update on Disability Awareness Training for AAPD and Use of Disability Resource Cards

Police Chief Baird discussed the use of the Disability Resource Cards throughout the Ann Arbor Police Department. Chief Baird is looking for feedback from the Commission on how the AAPD can improve services to those who are disabled, and from members of the public. Chief Baird mentioned that 1000 Disability Resource Cards were originally ordered earlier this year, and all 1000 cards have been handed out at this time. There are 1000 more cards on order that the Police Department will be handing out. Chief Baird left a few business cards so that anyone who

wishes to provide feedback can do so at anytime.

Steve Loveland from OHM Advisors began the presentation, as he is one of the leaders in the roundabout project. The team working on this project is seeking feedback about the roundabout. The project managers who presented mentioned that there has been a lot of fear from residents who live nearby regarding the flow of traffic, and inaccessibility issues that it might cause. - Discussion Regarding Crosswalk Uniformity

Cynthia Redinger gave an update on crosswalk uniformity. She spoke to the commission earlier this year regarding ideas for the project. The next steps for the project are to develop a draft of the guidelines, and they are also going to be developing a city-wide survey so that members of the public who are unable to make it to the meetings are able to participate. They hope to present the final guidelines for the crosswalks in November, and have the design changes finalized by January.

d Partners in Access Committee - Alison Stroud

A. Stroud presented a letter written by A. Schnitzer about the issues with the Michigan Flyer/AirRide system's accessibility for everyone. A. Stroud asked the commission for feedback or suggestions about the letter before it is sent. If the letter is approved today it will be sent to the Department of Justice, upon other recipients.

L. Keeler made a motion to approve sending the letter, seconded by Z. Damon. S. Petersen asked for additional comments.

S. Petersen would like the letter to include more of a description about how the current situation is contrary to ADA regulations, as A. Schnitzer mentioned. She would also like to add clarity about what problems this situation is creating. A. Stroud will send the letter around after the changes are made.

S. Petersen moves to approve sending the letter with edits, seconded by L. Keeler. All approved on a voice vote.

A. Stroud will also move forward with sending the Closed Captioning Ordinance to Sally for commission approval. She did not have any negative feedback or any suggestions for changes.

A. Stroud also discussed the AAATA's plans for training their drivers on disability issues. The Partners in Access committee has been working very hard with the AAATA, and will continue this work.
