I ROLL CALL

S. Petersen called the meeting to order at 3:16 pm.

II APPROVAL OF AGENDA

Immediately following the approval of the September 21 Meeting Minutes the discussion will take place about the Closed Captioning Ordinance. L. Davis also announced that Scott McFadden will be unable to attend the meeting today (listed under Public Commentary), but will join the commission next month. This has been removed from the agenda.

S. Petersen made a motion to approve, seconded by R. Benedict. All approved the agenda as amended on a voice vote.

III APPROVAL OF SEPTEMBER 21 MEETING MINUTES

A. Schnitzer brought a few spelling errors to Heather's attention, which will be corrected. S. Petersen also provided a correction to the chair report. Currently the incorrect part reads, "S. Petersen put together a summary of the Commission on Disability Issues for City Council." It should read, "S. Petersen put together a summary of the Commission on Disability Issues for the Sensory Garden event, but will put together a summary for City Council if there is interest."

L. Keeler moved to approve the minutes as amended, seconded by K. Westphal. All approved as amended on a voice vote.

A CLOSED CAPTIONING ORDINANCE

S. Petersen introduced the ordinance to the commission. K. Westphal will bring the ordinance forward to City Council once the commission has approved the language within the ordinance. Chris Frost from the City Attorney's office was present to answer questions about the language. A. Schnitzer moved to accept the ordinance pending language clarification, seconded by K. Westphal.

A. Schnitzer asked about the term "responsible person" as written in the ordinance. Chris Frost, City Attorney's Office, provided clarification to this definition. R. Benedict and Z. Damon asked for clarification on how an infraction might be issued if business owners do not comply with the ordinance.

Chris Frost recommended discussing the "effective date" to the Ordinance. A. Blixt recommended that the enforcement of the Ordinance be effective 90 days after City Council approves the Ordinance.

S. Petersen moved to amend the Ordinance, seconded by K. Westphal.

A. Schnitzer moved to approve the Ordinance as amended, seconded by K. Westphal.
