VIII COMMUNICATIONS

Presentation by Louey Guillan, CAN Community Center Director and Stephen Crano, Associate Community Center Director updated the board on CAN activities at Green-Baxter and Hikone. Partnering with M-Live for Warm the Children to provide \$90 in winter clothing for each child. Buying turkeys for each resident and having a Thanksgiving potluck. After school programs attended by 15-20 kids/day at Hikone and 12-15 kids/day at Green. Learning about emotional awareness and emotional learning. Partnering with the YMCA on fitness program. Art program with light sculpture installation on the property. Girl Scouts at Hikone. Partnering with U-M athletes to help teenagers consider receiving education through sports. 140 people received about \$50,000 worth of food during the year. Kim Pitts, Green-Baxter resident council member requested that the AAHC address the parking situation. 1 space per vehicle but guests take up spaces and not enough for tenants. Talked about city towing ordinance and why tow company is not towing vehicles without parking stickers. Julie Grand suggested tenants register complaints on a2fixit to raise awareness. GBC resident council will meet with AAHC staff to discuss whether assigned parking spaces will help.
