**I**      **CALL TO ORDER**

*L. Stambaugh called the meeting to order at 7:04 pm in the Basement Conference Room of Larcom City Hall.*

**III**      **SPECIAL GUEST PRESENTATION****a**      DEBRA KIRBY, SENIOR VP LAW ENFORCEMENT CONSULTING, HILLARD HEINTZE: PROGRESS REPORT, NEXT STEPS, ETC.

*Debra Kirby gave an update of how the process has gone so far, and what parts of the scope of work have been covered so far. As part of this process, Hillard-Heintze is focusing on and measuring six main areas of the Ann Arbor Police Department, and has been comparing them to other departments in the country. Two community listening sessions have taken place so far. Debra mentioned that the report is aimed to be completed by the end of the July, and the goal is to deliver the accepted/approved version of the report to the City by the end of the summer.*

*The commission discussed the need to go deeper into the community in*

*speaking with marginalized people. The commission urged Debra Kirby to do that.*

**b BAN-THE-BOX ISSUES REVISITED**

*L. Winkler gave the commission an overview about the meaning behind the "Ban-the-Box" policy in Ann Arbor, and how the laws are affecting other organizations across the country. L. Winkler asked the commission to consider encouraging the City to extend this policy to City contractors and potentially private businesses within the City, as the resolution passed by City Council in 2014 was only directed at City employees.*

*The commission discussed next steps in how to expand the policy around the City.*
