C PUBLIC COMMENTARY - (3 Minutes per Speaker)

Ethel Potts, 1014 Elder Boulevard, shared that the proposed location for the Fuller Park Train Station will have a great visual impact on the surrounding areas as well as an impact on the park. She also shared that the existing train station can be improved by adding an addition.

Vince Caruso, 556 Glendale Circle, expressed concerns about the Fuller Road Station site, citing parking, usage of park land, biking and pedestrian usage, and geographic location.

Rita Mitchell, 621 Fifth Street, thanked the Commission for their work keeping the parks in great shape. She shared that she is against the Fuller Road Train Station location due to its location and size.

Nancy Shiffler, speaking on behalf of the Huron Valley group of the Sierra Club, shared that using park land for transportation in Ann Arbor has never happened before. She added that a large impact would be created on the surrounding areas if a train station and a parking area is created where there is currently a park.

James D'Amour, shared that he was on the Parks Advisory Commission

from 2002-2003, and described that he finds the idea of selling park lands disturbing and encouraged the Commission to vote against a train station on park land.

Gwen Nystuen, 1016 Olivia Street, shared the significant impacts that would occur if the Fuller Road Train Station existed.

Barbara Bach, 2061 Day Street, shared that the Fuller Road Train Station would have significant impacts on the City of Ann Arbor and challenged the Commission to reclaim the space there to create a better park.

Scott Rosencrans, 3051 Lakeview Drive, gave details regarding Dolph Park and the Sister Lakes. He expressed support for the Sister Lakes Stormwater Improvement Project.

E SPECIAL PRESENTATIONS

E-1 17-1611 Review of 2017 Outdoor Pool Season

J. Landefeld, B. Meeks, B. Ruthven, and G. Hurn gave a presentation on the 2017 pool season. They highlighted improvements made this year, staff achievements, successes of the season, and upcoming improvements.

A. Jackson inquired about difficulties met by extending the pool season

relating to retaining staff. He also inquired about plumbing issues in some of the pool locker rooms.

- G. Hurn answered that there were challenges relating to retaining staff, however it was worth extending the season.
- B. Meeks answered that he is aware of and is working towards a solution to the plumbing issues.
- C. Smith added that there will be a resolution regarding upgrades to mechanical infrastructure at the pools soon.
- R. Kraut expressed appreciation for the extended pool season.

F NEW BUSINESS

F-1 Resolution to Recommend Approval of the Purchase of Two Zamboni Ice Resurfacers with Frank J Zamboni & Co Inc. for \$193,856.00

C. Smith explained that the resolution is for the purchase of two Zamboni ice resurfacing machines, and to sell the two Zambonis that are being replaced. He explained the need to replace two Zambonis, stating that the existing Zambonis are in need of constant expensive repair.

Commission Discussion:

The Commission discussed alternatives to replacing the two existing Zambonis, including making repairs, and keeping one of the existing Zambonis to use as a spare, Zamboni Storage, and the selling price of a used Zamboni. They also discussed amending the resolution to include the sale of at least one Zamboni instead of the sale of both Zambonis.

A motion was made by London and seconded by Jackson that the Resolution be approved by the Commission as Amended.

Whereas, Ice resurfacers are an essential component of maintaining quality ice at both Veterans Memorial Park Ice Arena and Buhr Park Ice

Whereas, Current Ice resurfacers are scheduled to be replaced in FY 2019;

Whereas, The Fleet & Facilities Unit needs to purchase replacement ice resurfacing machines for the City's fleet;

Whereas, Competitive bids were received by the National Joint Powers Alliance cooperative purchasing program;

Whereas, Frank Zamboni & Co. Inc. of Paramount, CA, received the contract for Ice Resurfacing Equipment;

Whereas, Frank Zamboni & Co. Inc. complies with the requirements of the City's Non-Discrimination Ordinances;

Whereas, Adequate funds for the purchase of these vehicles are available in the Fleet Services Fund FY18 budget and the Parks & Recreation Services General Fund FY18 operating budget; and

RESOLVED, That the Park Advisory Commission recommends City Council approves the issuance of a purchase order to Frank J Zamboni & Co. Inc. for two Zamboni Model 546 ice resurfacing machines in the total amount of \$193,855.95.

RESOLVED, That funds for the purchase of this equipment in the amount of \$187,652.07 comes from the Fleet Services Fund FY18 budget and in the amount of \$6,203.88 comes from the Parks & Recreation Services General Fund FY18 operating budget with funds to be available without regard to fiscal year; and

RESOLVED, That at least one of the two Zamboni ice surfacing machines being replaced be sold at the next City vehicle auction held after the vehicles are removed from service.

Resolution to Recommend Approval of a Contract with Aquatic Renovation Systems, Inc. to Install a PVC Pool Liner at Veterans Memorial Park Pool (\$134,805.00)

C. Smith explained the need for a new pool liner at Veteran's Memorial Park Pool stating that the current marcite lining material has reached the end of its useful life. He added that the pool is in a condition where it makes more financial sense to replace the liner instead of continuing to make repairs. He explained that the proposed PVC pool liner requires minimal upkeep and that it has a longer useful life than the marcite lining material.

A motion was made by Galardi, and seconded by Appel that the resolution be approved.

Approved Resolution reads as follows:

Whereas, The Parks and Recreation Open Space Plan recommends replacing the liner to prolong the integrity of the infrastructure and provide a better customer experience;

Whereas, The project supports the City sustainability goal of promoting active living and learning;

Whereas, Funding for construction is available in the approved FY2018 Park Maintenance and Capital Improvement Millage budget;

Whereas, Competitive bids were received by Purchasing on September 21, 2017 to replace the pool liner;

Whereas, Aquatic Renovation Systems, Inc. submitted the lowest responsive bid;

Whereas, Aquatic Renovation Systems, Inc. complies with the requirements of the City's Non-discrimination and Living Wage ordinances: and

RESOLVED, That the Park Advisory Commission recommend approval

of a contract with Aquatic Renovation Systems in the amount of \$134,805.00 and a construction contingency of \$13,480.00 (10%) to cover potential contract change orders for a total contract amount of \$148,285.00 for the life of the project without regard to fiscal year.

Commission Discussion:

The Commission discussed the feeling of the PVC material, the useful life, and the cost of the pool liner.

G-1 Update on Sister Lakes Stormwater Improvement Project- Scheduling and Construction

J. Lawson explained the Sister Lakes Storm Water Improvement Project briefly to the Commission. She described the project, explaining that Stormwater and debris will be captured before entering First Sister Lake. She explained that there is currently not a system in place for storm water collection at that location.

The Commission asked questions regarding maintenance and basin design.

J. Lawson explained that the project will be maintained by volunteers, Public Works staff, and Stormwater staff. She added that it is a one basin design.

The Commission briefly discussed the Treeline -Allen Creek Urban Trail resolution.

A motion was made by Galardi, seconded by Morrison, that the Resolution be Approved by the Commission.

Commission Discussion:

- S. Borgsdorf inquired about adding the project to the Master Plan. He also inquired about what about the Treeline Urban Trail project is being added to the Master Plan
- C. Smith answered that when a project is part of a Master Plan there is greater access to the resources needed to implement the project, particularly grants.
- C. Pulcipher responded that the plan is being included in its entirety; however, it is understood that the plan is aspirational/opportunistic and includes alternatives to aspects of the plan provided within the plan.
- A. Jackson inquired about the priorities of PAC if the Treeline Urban Trail project is adopted to the Master Plan.
- C. Smith answered that the priorities of the PAC and the LAC remain as they are.
- M. Appel expressed that he would be voting against the resolution as he felt there could be a better Master Plan.

Approved Resolution reads as follows:

Whereas, The City of Ann Arbor aspires to provide non-motorized transportation options to connect neighborhoods, businesses, parks, and the Huron River;

Whereas, The idea for an urban trail that roughly follows the floor of the Allen Creek floodplain and the alignment of the Watco Companies/Ann Arbor Railroad has been discussed for decades within the community;

Whereas, The Parks, Recreation and Open Space (PROS) Plan and the Non-Motorized Transportation Plan, official planning documents for the City of Ann Arbor, recognize the future creation of the Allen Creek Greenway (now known as The Treeline—Allen Creek Urban Trail)

Whereas, In 2011, the Ann Arbor City Council passed a Resolution in Support of the Allen Creek Greenway (The Treeline) recognizing its ability to address existing inadequacies in non-motorized connections within the community and specifically to the Huron River;

Whereas, The Ann Arbor City Council directed staff to develop a scope of work for a "master plan approach" for The Treeline—Allen Creek Urban Trail:

Whereas, The Ann Arbor City Council passed a resolution to adopt the FY2016 budget which included funding for staff support and consulting services for development of a master Plan for The Treeline—Allen Creek Urban Trail:

Whereas, The project team identified various groups to be involved in the process, including a Project Management Team, Technical Advisory Committee, Citizen Advisory Committee, and Stakeholders/Community at Large;

Whereas, The planning process for The Treeline—Allen Creek Urban Trail engaged stakeholders, community leaders and residents in shaping the scope, content, and direction of the plan during participation at 13 public meetings;

Whereas, Additional opportunities for public comment will be available as part of the City Master Plan approval process; and,

Whereas, The Treeline—Allen Creek Urban Trail Master Plan provides a framework for an essential non-motorized, north-south connection through Ann Arbor's richest cultural, recreational and economic assets, including surrounding neighborhoods and parks to the core of downtown Ann Arbor and University athletic facilities, while also linking to the Huron River, the regional Border-to-Border Trail and the state-wide Iron Belle Trail:

RESOLVED; That the Parks Advisory Commission supports The Treeline—Allen Creek Urban Trail Master Plan; and,

RESOLVED; That the Parks Advisory Commission recommends that the City Planning Commission and City Council initiate the process to adopt The Treeline—Allen Creek Urban Trail Master Plan as an element of the City Master Plan.

A motion was made that the Resolution be Approved by the Commission. On a voice vote, the vote was as follows with the chair declaring the resolution APPROVED. Vote: 7-1

E. Cooper explained the resolution regarding the Proposed Fuller Road Station stating that the purpose of the resolution is for the PAC to recommend the advancement of the project to City Council.

S. Borgsdorf discussed de minimis impact as it relates to the Fuller Road Station.

A. Jackson discussed the current use for the Fuller Road Station park land.

- R. Galardi inquired about bike trails relating to the Fuller Road Station.
- C. Smith clarified that the Border to Border trail is on the north side of Fuller Road.

A motion was made by Appel, and seconded by Galardi to approve the resolution as presented.

Resolution reads as follows:

Commission Discussion:

The Commission discussed setting precedent, vehicle parking for park use, revenue, negative impacts on the park, features to improve the park experience, and traffic mitigation. The Commission discussed amending the resolution to include "that the design of any structure in Fuller Park for a transit station accommodate those needs" after the second resolve clause.

Moved by Morrison, seconded by Galardi, that a friendly amendment be made to add additional language. Amendment accepted.
