Staff Update: Greenbelt RCPP was awarded, Bus Tour 2018

- *ACEP application deadline has been officially announced as February 16, 2018.*
- *Greenbelt RCPP was awarded 1.04 million dollars. Ruth Thornton plans to meet with NRCS and the partners involved to finalize the details and move forward in the process. She stated that the award may provide up to 50% of the funding needed toward the purchase price on conservation easements within the southern portion of Washtenaw County.*
