19-2172 December Staff Liaison Report

Vet's Park Upate

EDF Committee members do not want a single tree species planted. They have concerns about planting a monoculture. They would like to see a connection in the planting to the oak grove near the skate park. Committee members would like to see the following species, or similar mix of species, integrated into the planting plan:

- 1. Swamp white oak
- 2. London planetree
- 3. Red maple

Committee members would like to see a revised plan at the February 2020 meeting.

Cranbrook Park Tree Planting

Parks staff would like to plant one or two trees along the walking path in Cranbrook Park, for a not-to-exceed cost of \$600.00.

Bletcher moved to cover the costs of two trees to be planted by parks staff in Cranbrook Park, not to exceed \$600.00. Seconded by Wortman. Motion passed unanimously.

Hanover Square Park Tree Planting

Parks staff would like to fill vacant planting sites and remove declining trees at Hanover Square Park. They have two options up for consideration:
Option A: Planting two trees in the empty tree pits for a not-to-exceed cost of \$600.00.
Option B: Removing two declining trees and planting four trees in the tree pits for a not-to-exceed cost of \$1,200.00.

Wortman moved to approve accept Option B, covering the cost of four replacement trees in Hanover Square Park, with a not-to-exceed cost of \$1,200.00. Bletcher seconded. Motion passed unanimously.

Riverside Park Tree Planting

Parks staff are requesting succession plantings of redbud trees in the redbud grove in Riverside Park. They presented two options for consideration by he EDFC:

Option A: Planting 5 trees, for a not-to-exceed cost of \$1,500.00. Option B: Planting 10 trees, for a not-to-exceed costs of \$3,000.00.

Wortman moved to approve accept Option B, covering the cost of 10 replacement redbud trees in Riverside Park, with a not-to-exceed cost of \$3,000.00. Collins seconded. Motion passed unanimously.
