C-1 Staff Update

a. Budget Overview

Remy Long reported that the Greenbelt Fund has \$5,550,279.00 at the end of quarter one in 2018, which is the most recent audited balance for the fund. There are 22 projects in the pipeline, which includes those that the city is spearheading and pursuing as a partner with other conservation programs. That allots to a total of 2100= acres in the pipeline. The projects are in various stages of the process and not all been appraised. The estimated and appraised values are over \$6 million in value for the entire pipeline.

b. Recap Panel Discussion at AADL

Mr. Long reported that the the Ann Arbor District Library hosted a panel discussion on open space preservation on land-linking and land-access options for new and beginning farmers. The panel consisted of Mr. Long, Ginny Trocchio with Washtenaw County, Larry [Dahl] DOLL, boardmember on Legacy Land Conservancy, a young farmer by the name of Hannah and Kathy Sample of Argus Farm Stop. Each person spoke on behalf of their own initiatives and how they relate to the local food system, open space preservation and inter-generational transfer of farmland. The turnout was great and the meeting was recorded and is available online if anyone would like to watch it.

c. County Protected Land Mapping

Mr. Long showed the commission a map of protected lands in the Washtenaw County area. The impact to date moved to a relatively parks-heavy landscape which is clustered up near the Waterloo/Pinkney area between the years 2000 and 2019. Mr. Long felt that this was extremely indicative of the high density of conservation programs that are available in Washtenaw County and the ability for those programs to work along and with partners in the area to leverage funds for properties. The commission discussed the matter in more detail.
