F-2 19-2351

DR19-017; 340 E. Huron St. University of Michigan Credit Union A proposal to renovate the southern portion of this existing building by converting the existing enclosed loading area into useable space. Proposed southeast corner façade modifications include installing large windows. 2,390 sq. ft. of new floor area is proposed within the existing building. The existing loading dock is proposed to be demolished and replaced with a pedestrian entry area with service access, resulting in a net increase of the building size by 117 sq. ft. The existing dumpster will be relocated from the loading dock area to the southwest corner of the site. The parking area will be reconfigured to accommodate new 90 degree parking spaces and additional landscaping. The site is zoned D1 (Downtown Core) and is within the Midtown Character Overlay District.

The Design Review Board's discussion and recommendations is summarized below:

The proposed renovation and addition could take more design clues from the original building designed by Albert Kahn as well as the subsequent additions by others.

The proposed addition provides substantially more light into the building and improves access but some Board members felt that the proposal was not appropriate because it would establish a new architectural pattern for the building.

- Some Board members thought that the historic Albert Kahn façade could co-exist with a contemporary addition. That dual existence could include a restored north façade of the original building (primarily the original entry doors, which could be inoperable).
- The color of the proposed blue band is inconsistent with the colors of the established building.
- The access walk to the new addition on the south side of the building

should bring the granite vocabulary of the existing building into this walkway area including amenities.

 Consider providing an historic marker at the south end of the proposed dumpster screen which could highlight the work of Albert Kahn.
