G NEW BUSINESS

G-1 <u>19-1537</u> Sign Guidelines Amendment

Jill Thacher explained there has been a recent uptick in banners being hung downtown, and several businesses have asked whether long-term (weeks or months) banners may be hung on historic properties. Banners have historically been prohibited by Ann Arbor's sign code, but the new sign code is proposed to allow them. Therefore, staff requests that the Historic District Commission add to their design guidelines a prohibition on fabric and vinyl banners and pennants (or similar).

Moved by Jessica Quijano, seconded by Anna Epperson, to approve the revised Ann Arbor Historic District Sign Guidelines to include information on banners, and direct staff to post this information on the City website and include banners in a future update of the Ann Arbor Historic District Design Guidelines.

The Commission expressed the need to amend the sign guidelines to read: Banners, pennants, and similar temporary signs that are often made of fabric or vinyl are not appropriate in Ann Arbor's local historic districts. All signs must also meet the sign code: Chapter 61 of the Ann Arbor City Code, Sign & Outdoor Advertising.
