Moved by Commissioner Kathryn Fortener, seconded by Commissioner Bob White, that the Commission issue a certificate of appropriateness for the application at 312 S Ashley Street, a contributing property in the Main Street Historic District to: 1) remove the third floor rooftop structure and replace it with a smaller stair enclosure and patio; 2) replace the upper windows on the front elevation with aluminum windows;) 3) replace the existing storefront with a new aluminum and glass storefront system; and 4) install two signs on the front elevation, on the conditions that the signs are mounted through mortar joints, not masonry units and that the railing required will be installed as far from the roof edge as allowed by safety codes. The work as conditioned is compatible in exterior design, arrangement, texture, material and relationship to the rest of the building and the surrounding area and meets the Ann Arbor Historic District Design Guidelines for storefronts, windows, additions and signs, and The Secretary of the Interior's Standards

for Rehabilitation and Guidelines for Rehabilitating Historic Buildings, in particular standards 1, 2, 9 and 10 and the guidelines for storefronts, windows, building site, alterations for a new use, and additions.
