PUBLIC INPUT

EV Readiness Ordinance Discussion

- * How to integrate Level 1 charging into the ordinance, especially for workplaces and homes.
- * Energy Management option in more recent EV Readiness Ordinances
- * Precedents are hard to establish since EV Readiness Ordinances are relatively new
- * Integrating EV charging requirements into the parking table means that future developers will already be looking in this section of code
- * What are the justifications for the other #s in the chart (for example, bicycle parking)?
- * Can add signage requirements so that residents will know that a garage or lot has EV charging conduit or wired raceways available.
- * The Clean Energy Coalition's "How to Install EV Charging" report could be updated and shared with developers.
- * Need to take into account the affordability issues for low-income/affordable housing issues. Equity could go both ways

- * Need to define what Levels 1, 2, and DCFC are.
- * Wayne and John will add justification text for all of the land use types
- * Each workgroup member will review the draft ordinance and submit comments and make changes by the next meeting
- * Emily will ask Planning staff to look at the draft table for comments
