Floodplain Management Overlay Zoning District Resolution drafted by Commissioner Mitchell was amended after clarifying edits from Commissioner Gibb-Randall and Commissioner Needham.

NEW BUSINESS

20-1826

Council Member Kathy Griswold presented Council Enactment R-20-342 of Sept. 8, 2020 that requested the Environmental Commission to comment on Transportation Commission plans to re-write City Code Title III, Chapter 40 regarding landscaping on lawn extensions. After some discussion, it was decided that Chairperson Stephen Brown will draft a memo to Council and the Transportation Commission asserting the lack of clarity in the present City Code, rejecting the suggestion that Ordinance re-write be done exclusively within the Transportation Commission, and suggest that an ad hoc working group containing members of both the Environmental, Disability, and Transportation Commissioners perform this task to balance safety and sustainability values and clarify the language. Commissioners will be able to review, edit, then approve this memo before Chairperson Stephen Brown sends to Council and the Transportation Commission by Dec. 10. Chairperson Stephen Brown suggested that the Commission's annual internal review activities be tabled and taken up in a special working session before January 28.

There was general agreement, so Chairperson Stephen Brown will schedule this 2 hour meeting in December or early January by Dec. 10.

REPORTS FROM COMMITTEES, OTHER COMMISSIONS, COUNCIL, AND CHAIR

Natural Features Working Group: SEAS Capstone project proposal will be presented to students to recruit expertise for the natural features inventory. The heritage and landmark tree ordinance drafts will soon be ready for consideration by Council

Solid Waste Working Group: Construction and Demolition pilot project and ordinance goal is led by Chairperson Stephen Brown. Net Zero Waste group is growing, led by Council Member Lisa Disch.

Reports by Other Commissions: Parks none

Planning none:

Energy Commission: Several ordinances drafted by the Energy Commission are being considered by Council on Dec 21, particularly the EV Ready ordinance that should be supported by Public Comment. The lighting ordinance requires a little more work, and should proceed to Council during 1Q21.

Reports from Council: 4th Consent Judgment regarding the Gelman 1,4-dioxane groundwater plume and potential appeal to EPA for Super Fund designation is under discussion at Council. A new Court date has been scheduled for January 11-13, 2021, where testimony will be heard from the various stakeholders.

Report from Chairperson: Public comment to the State Legislature about raising or eliminating the 1% Cap on distributed solar electricity is urgent. Please contact your state reps and the MPSC to support the "Powering Michigan Forward" bill package, especially SB 597 and HB 5145 to prevent blocking installation of solar panels by citizens and residents, which is now imminent.

REPORT FROM STAFF

Report from Staff: The A2zero Climate Ambassadors recruitment has been a great success, where 23 of 60 applicants could be accommodated for training and outreach goals. Meetings are every Wednesday from 7PM-9PM.
