**b CHAIR REPORT - ZACH DAMON**

*Z. Damon gave the chair report. He has been working on obtaining updated crash data post 2013 and, while he has been unable to find Ann Arbor specific data, will be reaching out to the City directly in the hopes of obtaining City specific data.*

Finally, he also announced his intention to seek a second term as chair during the November election.*

**1 CLOSED CAPTIONING FOR ANN ARBOR INCLUSIVE**

*R. Hawkins has been in communication with Linda Evans and Melissa Bondy, with discussions ongoing regarding the costs of closed captioning for Ann Arbor Inclusive. Recent meetings with them have been cancelled due to the pandemic.*

*Z. Damon will be reaching out to Lisa Wondrash regarding if the City will be continuing to pay for closed captioning for Ann Arbor inclusive or if that will no longer be needed with programs like Zoom and Youtube has closed captioning ability already.*

**d PARTNERS IN ACCESS COMMITTEE - LARRY KEELER**

*L. Keeler will be looking to put together an agenda over the next two months with D. Poster and A. Gossage, with the intention of having one set for September.*

**e RECRUITING ACTIVITY - LARRY KEELER**

*Two commissioner spots have opened up on the commission. L. Keeler and E. Nelson will be meeting to review five previous applications and reach out to them to see if they might still be interested in joining the commission.*

**f      TRANSPORTATION COMMISSION UPDATE - TIM HULL**

*T. Hull provided an update on the Transportation Commission, which included the Healthy Streets Initiative and the closing of streets on weekends for dining. L. Keeler inquired about the A-Ride contract not being renewed with TheRide, which T. Hull reported hadn't been discussed at the Transportation Commission yet, and also about the Micro-Mobility initiatives, which is reportedly still with Legal. K. Mozak-Betts reports that services for the A-Ride will be handled in-house starting in August.*

*Also discussed was the pandemic related service reduction and gradual reactivation of service with the Ann Arbor Transportation Authority. Park and Ride routes are being phased back in, with routes currently only running at peak hours. K. Mozak-Betts urges members of the public to reach out to TheRide with any concerns or feedback they have at [TellUs@theride.org](mailto:TellUs@theride.org)*

*Finally, there has been discussion with DDA parking management regarding the future of ADA parking spots. If any concrete decisions were to be made in the future, the Commission on Disability Issues will be contacted for coordination. T. Hull will provide any further updates if he hears them.*

**g U OF M COUNCIL FOR DISABILITY CONCERNS MEETING UPDATE - KATHLEEN MOZAK-BETTS**

*K. Mozak-Betts provided an update on the Council of Disability Concerns. Due to difficulties with the pandemic, meetings have transitioned to Zoom with CART providing closed captioning. The next meeting will be held on July 14th at noon.*
