Suggest Metrics for ecological improvement related to IPM and Natural Features improvements. Will not move quickly, but long-term trends need to be consistently measured over time. (Commissioner Chris Graham, Commissioner Rita Mitchell, Commissioner Karie Slavik)

Going forward, OSI staff will submit asks to Working Groups for discussion and refinement, then proceed to full Commission for discussion (Missy Stults, Commissioner Stephen Brown, Commissioner Robert Needham, Commissioner Chris Graham, Commissioner Karie Slavik)

# REVISED GOALS IN RESPONSE TO A2ZERO

The working groups will announce and discuss their revised goals, in light of Missy's suggestions last month

One Commissioner will be assigned to move each goal such as C & D.

The Commission would like a more refined document for City Staff by Sept 2020

In October or December we would like to vote on a draft ordinance to pass on to Council

Commissioner Shannan Gibb-Randall would like to move the document to Oct instead of Sept. 2020

Solid Waste Working group shared minutes with action points and commissioners who will take charge with moving the document

Water, Natural Features, and Pollinators working group also shared their minutes on the same document

Commissioner Steve Brown will give everyone editing rights on the Google doc.

Commissioner Robert Needham also presented the water working group minutes to the Commissioners.

Goals for green streets will be brought up to the entire Natural Features group in August.

Commission can send an email to Hillary Hanzel in Parks suggesting educational signs at Argo livery

Chair Steve Brown will share documents with Commissioner Robert Needham on micro plastics

Commissioner Karie Slavik said the pollinator working group is working with City staff on IMP and creating a training for pesticides and turf grass.

Chair Steve Brown wanted the group to create SMART Goals for the

group

Commissioner Mike Appel suggested a SEAS Capstone project to have ready by Sept.

Commissioner Jonathan Overpeck said they should discuss with faculty and client then ready be ready to present to students.

Commissioners are asked to submit a few sentences to a paragraph to him then he will call and ask a few questions to get a 10,000 foot view of the project.

Some folks at SEAS would work with faculty to shop the projects around.
