1. Scott Rosencrans

A motion was made by Commissioner Ezekiel, seconded by Commissioner Santi Hall, that the meeting reconvene. On a voice vote, the Chair declared the motion carried and the meeting reconvened at 6:19 p.m.

MOTION #1 - Application No. 2006-10

A motion was made by Commissioner Santi Hall, seconded by Commissioner Omenn, to direct staff to commission an appraisal on the property identified in Application No. 2006-10 in the beginning of 2010 and to recommend to City Council to apply for Federal Farm and Ranch Land Protection Program Funds for the 2010 grant application round, since local soils now qualify for FRPP

funding. On a voice vote, the Chair declared the motion carried.

MOTION #2 - Application No. 2005-025

A motion was made by Commissioner Santi Hall, seconded by Commissioner Bloomer, to direct Staff to meet with the land owner and Webster Township to see if donations are possible for the property identified in Application No. 2005-025. On a voice vote, the Chair declared the motion carried.

MOTION #3 - Application No. 2007-01

A motion was made by Commissioner Santi Hall, seconded by Commissioner Omenn, to direct staff to meet with the land owner about contribution for Application No. 2007-01. On a voice vote, the Chair declared the motion carried.

MOTION #4 - Application No. 2009-02

A motion was made by Councilmember Hohnke, seconded by Commissioner Ezekiel, to recommend to City Council to partner with Webster Township for the Purchase of Development Rights on the farm as identified in Application No. 2009-02 and to recommend to City Council to allocate additional funds for the acquisition for a total City contribution not to exceed \$590,257.00 because of the contributions from the land owner, Webster Township and also the connection with lake on the property to the Huron River and the matching funds in the amount of 37.5%. On a voice vote, the Chair declared the motion carried.

MOTION #5 - Application No. 2009-01

A motion was made by Commissioner Santi Hall, seconded by Commissioner Bloomer, to direct Staff to request contributions from the Legacy Land Conservancy and Lodi Township for the Purchase and Development Rights on the farm identified in Application No. 2009-01 and to accept the land owner donation in the amount \$153,000.00 (16.5%), to further recommend to City Council to allocate additional funds for the Purchase of Development Rights on the farm, for a total City contribution not to exceed \$835,400.00 and to recommend that City Council partner with the Legacy Land Conservancy and Lodi Township should a contribution be approved by their respective governing bodies. The Greenbelt Advisory Commission recommends this because of the focus on the local food of this property, the high visibility and to the crop land. On a voice vote, the Chair declared the motion carried.

Resolution Regarding Purchase Price and Matching Funds for Greenbelt Purchases

Commissioner Hall presented a resolution regarding purchase price and matching funds for Greenbelt purchases to the commission. She said that the resolution is being proposed to reaffirm the Commission's commitment to purchase prices that would essentially maximize the value of the millage. This would say to the public that it is the Commission's intent to get the lowest price possible on every purchase, thereby having more dollars. A copy of the resolution is on file in the City Clerk's Office.

The commission discussed the proposed resolution and made the following recommendations:

The resolution be administratively amended as follows:

2nd to Last RESOLVED Clause:

...RESOLVED, in the event that matching funds (from federal, state, county, township, PRIVATE SOURCES or other sources) are applied for and not received ...

Last RESOLVED Clause:

RESOLVED, the Greenbelt Advisory Commission would like to ask staff to amend the Greenbelt application to include the following text with prominent placement: ["Barring exceptional circumstances,] applicants should be advised that the Greenbelt Advisory Commission is unlikely to purchase ...

Staff was asked to provide the 2007 resolution relating to purchase price and matching funds for Greenbelt purchases and to provide history of the difference between appraisal prices and purchases of similar transactions.

A motion was made by Councilmember Hohnke, seconded by Commissioner Omenn, that the Resolution be Postponed to the Greenbelt Advisory Commission and should be returned by 10/21/2009. On a voice vote, the Vice Chair declared the motion carried.

2. Election of Officers

A motion was made by Commissioner Hohnke, seconded by Commissioner Ezekiel, that Commissioner Rubin be appointed as the Chair of the Greenbelt Advisory Commission. On a voice vote, the Vice Chair declared the motion carried.

3. Webster Township Millage

Peg Kohring, informed the Commission that Webster Township will have a millage proposal on their ballot in November 2009.

Commissioner Bloomer said that the Webster Township's millage is about to run out and State Law requires a renewal of that millage. They cannot wait until next year. The Township Board has submitted language to the County Clerk for renewal of the millage for five years.
