Blaine Coleman, resident, spoke against sending military aid to Israel.

4. Mozhgan Savabieasfahani - We are Against Sending Military Aid to Israel

Mozhgan Savabieasfahani, resident, spoke against sending military aid to Israel.

5. Decky Alexander - Social Justice Resolutions

Decky Alexander, resident, urged City Council to not nurture hate speech, and also stated international politics are not the job of City Council.

6. Emilia Callan - Deer Cull Amendment in City Budget (DS-1)

Emilia Callan, resident, spoke in opposition to the deer cull.

7. Elizabeth Hunter - Deer Cull Amendment in City Budget (DS-1)

Elizabeth Hunter, resident, spoke in opposition to the divisive nature of the Council, noting several identical amendments were offered by opposing Council Members, showing an unwillingness to work together.

CC COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER RAMLAWI

Councilmember Ramlawi discussed the ongoing war crimes in Gaza, and the United States' action to block the United Nations from releasing a ceasefire statement. He expressed frustration about the Palestinian conversation locally.

COUNCILMEMBER GRISWOLD

Councilmember Griswold provided an update on the Gelman Plume and stated the City is currently undertaking a three-prong approach to clean-up involving consent judgments and the EPA assessment.

COUNCILMEMBER SONG

Councilmember Song thanked Councilmember Ramlawi for his openness and sharing about Palestine. She also encouraged residents to participate in the United Way 21-Day Equity Challenge at www.uwwashtenaw.org/equity.

COUNCILMEMBER DISCH

Councilmember Disch acknowledged the events of the past week in the Middle East, noting the violations of international law.

COUNCILMEMBER RADINA

Councilmember Radina stated that May 17th is the International Day Against Homophobia, Transphobia, and Biphobia, and acknowledged the LGBTQ+ population in Ann Arbor.

COUNCILMEMBER HAYNER

Councilmember Hayner discussed the conflict in the Middle East and spoke in favor of a resolution in support of Palestine.

COUNCILMEMBER BRIGGS

Councilmember Briggs highlighted that May 20th is the deadline for the A2Zero Champion nomination.

COUNCILMEMBER GRAND

Councilmember Grand discussed the prevalence of anti-Semitism in the community, and the need to call out hate at the local level.

MC COMMUNICATIONS FROM THE MAYOR

Mayor Taylor discussed his hope that the City Council could begin to focus less on personal issues and more on legislative matters, but did acknowledge recent comments by Councilmember Hayner during an interview. Mayor Taylor stated that he planned to address this issue through the proper recourse procedure.
