Commissioner Clevey addressed the likelyhood of a municipal utility needing to have a portion of its energy portfolio come from fossil fuels.

ENERGY REPORT - NEWS FROM THE ENERGY OFFICE AND COMMISSIONERS

Staff Stults gave updates from the office that included progress on the Municipal Solar RFP. She also covered the a Federal ask for funding of projects including storage systems, transportation elements, and all electric firestation. She covered information on an upcoming heatpump workshop. She also gave an update on the planning at Bryant community in collaboration with RMI. Finally, she informed the commission about RMI and the joint meeting with planning

Commissioners discussed the costs of heat pump conversions and had questions on the solar installations.

Green Belt Presentation - Remy Long

Remi Long who works on the Greenbelt program for the conservation fund gave a presentation on the Greenbelt program. In his presentation he covered the history of the greenbelt, the green belt mileage, and the recent Greenbelt acquisitions. He went over the recent strategic plan update and the metrics they are tracking in collaboration with OSI. He finished by going over Greenbelt requirements that limit the ability to install solar.

Commissioners asked questions about the requirements that restrict solar especially as it pertained to impervious surfaces. There were question about biodigesters and further conversation about lands that are better for solar vs farming.

Building Code Update - Jan Culbertson & Chuck Hookham

Commissioner Hookham covered state and local building codes as they relate to building emissions. He also covered what could be done to support efficiency upgrades in the current legal climate.

Jan Culbertson the chair of the 2030 district did a presentation on the zero code. She focused on the renewables appendix, and how it related to the 2021 IECC requirements. In the second half of her presentation she went over the process of adopting the Energy Code and was to support implementation of the renewables appendix of the code.

Commissioners discussed supporting building policies. Staff Wass-Smith gave an update the current IECC process. There were questions about afford ability, the stretch code and the process with LARA.

Working Group Updates

Staff Stults gave a quick update on the City's VGP intervention. And Commissioner Colvin Garcia gave an update on the EV working group.

Report from Environmental Commission

Chair Mirsky gave an update on the Environmental Commission which included conversations around Solid Waste.

PUBLIC INPUT

Resident and previous chair Wayne Appleyard stressed the importance of recognizing the need to understand the relationship between solar and the grid especially as it pertained to production during the winter months where batteries have a hard time closing the gap.

Resident Guss Detchy called in support of municipilization.

ITEMS FOR NEXT AGENDA

The Commissioners would have a presentation by RMI on electrification and a presentation on the Solar Faithful model.
