*Eli Cooper, City's Transportation Program Manager, provided a brief introduction of the Transportation Plan and Stacey Meekins, City's Consultant for the 'Ann Arbor Moving Together Towards Vision Zero Plan'.*

*Stacey Meekins and Sam Schwartz reviewed the Plan with the Commissions.*

*Scott Cole, 1319 West Huron Street, Ann Arbor, Jackson Huron Neighborhood Association, spoke of their work with the City, noting their busy neighborhood isn't mentioned in this plan. He spoke in support of the proposed plan, asking for all neighborhoods to be included and for their neighborhood to help bring a human element to the plan.*

*Larry Deck, 3050 Lorraine Street, Ann Arbor, Boardmember of the Washtenaw Bicycling and Walking Coalition, expressed appreciation for the planning process, staff, and team responsiveness to comments. He spoke of three comments that they felt may be addressed in the final draft but hadn't been adequately addressed earlier; distracted driving, bicycling lane continuity, and the Border to Border Trail efforts.*
