Libby Hunter, 827 Bruce, serenaded Council on the process that the City uses to make spending decisions including the Budget, Annual Service Contract with RecycleRewards, the Amendment with Recycle Ann Arbor, the contract with William R. Wheeler, the Agreement with MDOT, and the Environmental Assessment Study for the Runway Extension at Ann Arbor Municipal Airport.

3. Kathy Boris - Single Stream Recycling (DS-5)

Kathy Boris, 1726 Charlton, addressed Council regarding single stream recycling. She said that the City already has a viable working system for recycling.

4. Rita Mitchell Contract with RecycleRewards and Contract Amendment with Recycle Ann Arbor (DS-4 & DS-5)

Rita Mitchell, 621 Fifth Street, asked Council to vote no on the contract with RecycleRewards and the contract amendment with Recycle Ann Arbor. She said that It would save up to \$6 million dollars in the budget if Council voted no on the two resolutions.

5. Glenn Thompson Contract Amendment with Recycle Ann Arbor (DS-5)

Glenn Thompson, 100 Longman Lane, spoke in opposition of the proposed contract amendment with Recycle Ann Arbor. He said that it is not a significant benefit to citizens.

6. Edward Shaffran - Main Street Biz (F-1)

Edward Shaffran, 209 S. Fourth Avenue, Suite 1C, thanked Council for their support of the Main Street Biz Initiative. There was a 95% consensus to approve the Main Street Biz Initiative. Mr. Shaffran also thanked the City Clerk, City Assessor and Assistant City Attorney Kevin McDonald for all of their help with the project.

7. Lou Glorie - Single Stream Recycling (DS-5)

Lou Glorie, 827 Brooks Street, spoke in opposition of the single stream recycling contract.

 Lily Au - Neighborhood Stabilization Funds to Community Housing Alternatives (DS-17 and DS-18)

Lily Au, 682 Peninsula Court, spoke in support of the proposed resolutions regarding Neighborhood Stabilization Funds to Community Housing and Habitat for Humanity of Huron Valley. She asked for help with shelter for the homeless in Ann Arbor.

9. Marcia Federbush - Comments about a Human Rights Commission Member

Marcia Federbush, 2000 Anderson Court, expressed concern regarding the appointment of Neal Elyakin to the Human Rights Commission.

10. Henry Herskovitz - Iraq

Henry Herskovitz, 404 Mark Hannah, addressed Council regarding the issues going on in Iraq.

COMMUNICATIONS FROM COUNCIL

COUNCILMEMBER SMITH

Councilmember Smith asked that Council consider moving its July 19, 2010 meeting to July 20, 2010 because July 19th is the date of the Townie Street party.

Councilmember Smith announced that the 2010 Census would be delivered to households this week. She said that it is crucial that everyone take the time to fill it out and return it so that Ann Arbor is properly counted.

COUNCILMEMBER ANGLIN

Councilmember Anglin addressed the public regarding Fire Services in the City. He said that he supports the Fire Department coming out to calls in the City that are not necessarily fire related, because they are helping to saving lives.

MAYOR HIEFTJE

Mayor Hieftje said that he attended the funeral services of former Mayor Samuel Eldersveld at St. Andrews Church. Mr. Eldersveld was Mayor of Ann Arbor from 1957 to 1959 and he had an excellent career at the University of Michigan.

City Administrator Roger Fraser said that the budget would formally be presented to Council on April 19, 2010. Hard copies would be distributed at the first meeting in April and time would be reserved at the April 12, 2010 Working Session to walk through the content of the budget. Presentations from SPARK and the LDFA would also be given to Council at the April 12, 2010 Working Session.

REQUEST FOR INFORMATION TO GOOGLE

Mr. Fraser said that they are continuing to work on the application submittal to

Google in response to the Request For Information (RFI). Mr. Fraser noted that the City has had interesting feedback from the community and participation and support in many different ways. The deadline for submittal to Google is March 26, 2010.

BOARD OF REVIEW

The Board of Review has begun their work on appeals of property tax assessments. The number of people who serve on the board was expanded this year due to the number of applications received last year. Numbers for this year will be reported to Council at a later date.

STREET SWEEPING RESUMED

Mr. Fraser said that street sweeping has resumed for the season.

WATERMAIN ON THE EAST SIDE OF TOWN

The watermain that serves Washtenaw Community College was taken out of service this past week. The watermain will be replaced, hopefully reducing the number of emergency calls the City receives in that area.

DEMOLITION OF THE BASEMENT OF CITY HALL

Demolition work in the basement of City Hall has caused some dust and smells in the building that have been difficult for people on the first floor. Temporary adjustments have been made for work locations of those employees. Construction will begin on the new elevator tower by the first of April.

CONTRACTING WITH MANPOWER

Mr. Fraser reported that as the number of temporary employees has reduced and as the budget has been reduced, it is no longer cost effective to continue the contract arrangement with Manpower for the recruitment of temporary employees. The City will take over hiring temporary work in-house within the next couple of months.

PARKS AND REC ACTIVITY GUIDE

A new Parks and Rec activity guide is now available. There are all sorts of activities available in the guide. Leslie Golf Course plans to open on March 25, 2010 and Huron Hills opened last week.

In that event, people addressing Council tonight would not be able to speak on the hearing in the future, as it would be a continuation of this public hearing.

Ignacy Justyna, resident of the Arbor Hills subdivision, said that there are laws pending in the State legislature that are dealing with cell phone usage and it didn't make sense to create an ordinance for a six mile radius that would be different than laws and regulations in surrounding areas, in the State and other cities.

Nancy Merdzinski, executive officer for the Ann Arbor Area Board of Realtors, said that the Board took the position of opposition of the proposed ordinance. The issue should be handled at the State level for uniformity and enforcement throughout the State. A local ordinance is unfriendly and unwelcoming to the large number of out-of-town drivers attracted to the City.

There being no further comment, the Mayor declared the hearing continued until April 15. 2010.

A public hearing was conducted on the proposed Resolution to Urge the Selection of the City of Ann Arbor as a Google Fiber for Communities Trial Location. Notice of public hearing was published March 12, 2010.

Steve Pierce, resident of Ypsilanti, and co-founder of Wireless Ypsi, stated he was excited that Ann Arbor was taking on the challenge of submitting the RFI proposal. It is great news not only for the City of Ann Arbor, but for the region. He stated the Wireless Ypsi group would lend their support to A2 Fiber and the Google Fiber RFI and encouraged residents from Ypsilanti and surrounding area to get involved in the project, by Twittering and putting videos on You Tube in support of the proposal.

Amin Ladha, Chief Information Officer of Washtenaw Community College, applauded the City for responding to the RFI. He stated that the project would absolutely benefit the community and it would bring and encourage businesses to come into the area. His office and Washtenaw Community College stand behind this effort and are willing to do anything to help.

Wes Vivian, 3875 E. Huron River Drive, said that he was in favor of the City working with Google. He said that the City should consider installing the fiber even if they do not get the money to do so from Google.

Dominic Serra, of Internet 123, said that he supports Ann Arbor's efforts with Google's RFI, and his company is in full support and willing to do whatever they needed to show their support.

Brian Robb, Ypsilanti resident and Councilmember for the City of Ypsilanti, said that he would be offering a resolution in support of the Ann Arbor Google project at this week's Ypsilanti City Council meeting. Councilmember Robb stated this would be great not only for the City of Ann Arbor, but for the entire region.

Amy M., resident of Ann Arbor, said that she was excited about Google possibly providing this service. She added that the excitement was not just hers, but of friends not living in Ann Arbor.

Chris Leher, student at the University of Michigan, said that there is a great deal of excitement in the University in support of the Google fiber measure. The University students are behind it, the Facebook group is growing to show support for it, and he

encouraged the University to work with the City to help promote it.
