# 1. Jim Mogensen - Human Services Funding Process (DS-7 & DS-11)

Jim Mogensen, 3780 Greenbrier Dr., addressed Council regarding the Human Services Funding Process and the multi-year operation agreement with the Office of Community Development and Washtenaw County. He said that throughout the country, the public sector has been out-sourcing the social safety net to the non-profit sector. The process is good, however, there needs to be some kind of a coordinated process.

# 2. Hugh Morgan - Human Services Funding Process (DS-7)

Hugh Morgan, 558 Glenmore Dr., chair of the Ann Arbor Area Community Foundation, addressed Council regarding the coordinated funding process for Human Services. Mr. Morgan stated that the AACF board unanimously approved and supports the coordinated funding process.

# 3. Lily Au - Human Services Funding (DS-7)

Lily Au, 685 Peninsula Ct., addressed Council regarding the Human Services Funding process. She said that the coordinated funding process is not legal because Mark Ouimet, vice-chair of the Washtenaw United Way, has a conflict of interest there.

# 4. Kermit Schlansker - Energy Research Farm

Kermit Schlansker, 2950 Marshall, addressed Council regarding an Energy Research Farm. He said that local government can easily form a totally significant energy project by sponsoring an energy research farm. The farm would help research how to heat and power buildings from land by using conservation, solar, wind and bio-mass.

# 5. Libby Hunter - MRF Cost Overruns (DS-9)

Libby Hunter, 827 Bruce, serenaded Council in opposition to the rising costs at the MRF facility and the proposed changes.

# 6. Nicholas Nightwine - Labor Relations

Nicholas Nightwine, 2500 Packard, President of AFSCME Local 369, addressed Council regarding labor relation violations of city managers. He said that AFSCME workers are watching their jobs disappear one by one to temporary workers and contractors. The contract between the union and the City states that jobs vacated due to attrition cannot be filled with a temporary worker. He asked that Council consider these matters and take the proper action to protect the hard work the dedicated union members do around the city.

#### **COMMUNICATIONS FROM COUNCIL**

#### **COUNCILMEMBER HOHNKE**

Councilmember Hohnke said that the State of Michigan has its first full net-zero home, which is located in Ann Arbor on South Seventh Street.

He also noted that he and Councilmember Teall are working on a resolution regarding the use of drinking water funds. Councilmember Hohnke stated they want to provide guidance to staff that drinking water funds should be used for drinking water related initiatives. The resolution is expected to come before Council at a later date

# COUNCILMEMBER BRIERE

Councilmember Briere wanted to clarify a comment made by a member of the public regarding Human Services Funding. The United Way, the Ann Arbor Area Community Foundation and tax dollars, both County and City, are not being co-mingled. What is being proposed and what Council decides tonight is whether the different funding agencies want to share a set of policies setting priorities, setting a shared agenda, but not setting a shared budget because each of those entities would allocate their own funds.

City Administrator Roger Fraser pointed out that part of the issue has been that each of the agencies has been making decisions about the use of their funds without consideration of what other agencies are doing, or may be doing for the very same people or the very same non-profit organizations. The primary benefit of the program is nothing more than communication about what the needs are and how best to use the available resources. Each of the agencies will continue to make their own recommendations, but only after the benefit of discussion about what those collective needs are and how they might best be served.

#### COUNCILMEMBER KUNSELMAN

Councilmember Kunselman said that two houses in the Springbrook subdivision are under renovation by Habitat for Humanity. Councilmember Kunselman stated there is an effort in Ann Arbor to promote and provide affordable housing to residents.

#### **COUNCILMEMBER HIGGINS**

Councilmember Higgins said that she would be bringing forward a resolution at the next Council meeting asking for an extension of the deadline for the Design Guidelines Committee. She asked that the City Administrator schedule a Work Session with the committee in January 2011 to explain the proposed guidelines to Council.

# COMMUNICATIONS FROM THE CITY ADMINISTRATOR

# SUMMARY OF CONSTRUCTION PROJECTS

City Administrator Fraser updated Council on the following construction projects:

Plymouth Road watermain replacement project 12-inch watermain east of Barton Drive; street pavement is restored and all traffic lanes are open. Geddes Road at US-23 is open.

Miller Road work continues until November 24, 2010.

West Stadium final lift of asphalt was completed November 4, and the street opens on November 5 to 2-way traffic.

Mr. Fraser announced that the City had received federal funding for the Stadium Bridges Project. He stated the project now has in excess of \$17 million in grant funding for the \$23 million project. The community has been exceedingly helpful in getting the support necessary before Congress to get the allocations for the project. Mr. Fraser thanked the people and businesses and other interested groups that came to the City's assistance in support of the applications for the project.

#### HOME BUILDERS ASSOCIATION AWARD 2010 PILLAR AWARD

The Builders and Remodelers Association of Greater Ann Arbor, formerly the Home Builders Association, awarded their 2010 Pillar Award for outstanding government agency to the Building folks in Planning and Development Services for the work that they do in support of the Association. This is a hallmark of how Planning and Development Services have committed to changing the way they do business over the last several years.

#### PARKS AND RECREATION SENIOR CENTER

The Parks and Recreation Senior Center received an \$18,000 grant from the Helen McCullough Trust which will be used for equipment that would improve programming and rentals at the Senior Center.

#### BUHR PARK ICE ARENA

The Buhr Park Ice Arena is open. The facility opened on November 1, three weeks earlier than ever before. This was made possible due to subfloor cooling improvements that were made last year. The hope is to extend the Buhr Park skating season through April 1.

#### PRESS RELEASE REGARDING THE CIP SURVEY

A press release was issued to the community regarding the CIP Survey. The survey is an opportunity for residents to provide comments regarding their satisfaction with public facilities, services, thoughts about the allocation of dollars for capital projects, ideas and priorities for improvements to facility systems and services, and suggestions for future public engagement methods. # POLICE/COURT BUILDING UPDATES

Police personnel will begin the move into the new building this week. The move-in process will take several weeks to finish as personnel are moved in stages. Mr. Fraser said notifications will be made as services are moved. The courts will begin with Probation moving in the middle of December and the courthouse operations will move in the early part of January 2011.

Mr. Fraser noted that a number of changes will take place in City Hall as well. Community Services Administration and Parks and Recreation Administration will move over to the 7th floor of the City Center Building temporarily. That same group will move back into the first floor of City Hall in the later part of April 2011.

Planning and Development Services will move temporarily from the 6th floor down to the 5th floor and will permanently relocate to the 1st floor of City Hall in May 2011.

The 2nd floor of the Larcom building will be closed during the months of January and February 2011. Council meetings will be held in the County Commissioners Chambers located in the County Building during that time. The City Clerk's Office will be relocated to the first floor of the City Center Building in January and returning back to the 2nd floor of City Hall in the early part of March 2010.
