APPROVAL OF MINUTES

22-1018 ICPOC May Meeting Minutes

SPECIAL PRESENTATION

Eli Savit, Washtenaw County Prosecutor; Abortion Rights in Ann Arbor

Washtenaw County Prosecutor, Eli Savit discussed the Supreme Court decision on Roe vs Wade and how that affects Ann Arbor. His office will

not prosecute doctors or patients. The old 1931 law to criminalize abortion is currently blocked by the courts-abortion remains legal in Michigan. There are two lawsuits currently pending: Plan Parenthood and Governor Whitmer's lawsuit in the Michigan Supreme Court. There is abortion protection-reproductive zone of freedom is legal in the State of Michigan.

NEW BUSINESS

Police Intervention in Abortion

L. Jackson discussed police intervention in abortion services. ICPOC wants to examine and suggest an ordinance for City Council to provide further protection for seeking abortion services in the State of Michigan. To ensure no arrest for providing, facilitating or receiving services in Ann Arbor and prevent the police from participating in such actions. L. Jackson had worked on a draft ordinance she will circulate to the commission and add to August agenda.

Report from Brady List

L. Jackson discussed what is the Brady List and how it provides names of police officers who have been untruthful. Highlighting Wayne County makes their list public and suggest Ann Arbor and Washtenaw County prosecutors office to make their list public too. S. Cater discussed the NACOLE webinar and ask the question; Does Ann Arbor have such a list of officers who can not testify and how does ICPOC get involved? S. Carter will create a formal inquire for August meeting.

Collaboration and Improvement Police-Community Relations

M. Othman discussed AAPD research project Sgt. Dunlap is working on titled Improving Police-Community Relationships. Part of the research will be interviews with 2 commissioners from ICPOC, 1 City Council liaison and members from the AAPD. He encourage commissioners to participate to help build trust between AAPD and the community, it's importance to include ICPOC's voice. Commissioners can remain anonymous.

M. Othman announced completed reviewed complaints will be shared with Information Managers and the commission in the near future.

COMMUNICATIONS

Dez Squire, Senior Racial Equity Organizer; Michigan Rountable for Diversity and Inclusion, discussed Southeast Michigan Regional Criminal Justice Accountability Board their 3 year plan to compile and analyze available data of racial disparities from law enforcement/citizen contacts to launch a regional accountability board spanning Wayne, Oakland, Macomb, Washtenaw and Genesee counties including Detroit.

L. Jackson gave a brief statement on the upcoming election for City Council. In an effort for ICPOC to remain a-political and transparent she is supportive of ICPOC member Cynthia Harrison. She will co-endorse Angeline Smith (Ward 1) and looks forward to working with either candidate in the future.
