Michael Aman Tedla Sr. (grandson of Robert Hayden), 812 Holly Boulevard, Ann Arbor, spoke to the legacy of Robert and Erma Hayden House. He was in support of the proposed Hayden House Historic District. Kemba Braynon, AIA Architect and Historic Preservationist working at Quinn Evans Architects, Ann Arbor, Chair of The Michigan State Preservation Ward, and personal friend of the Hayden family spoke of the importance of preserving the history and legacy of the Robert and Erma Hayden House and the Hayden Family and what they have meant to the community and this Country.

Daniel S Levin, 1508 Westminster, spoke in support of the Landmark House and gave his full support and approval of the proposed Hayden House Historic District.

The work as proposed is compatible in exterior design, arrangement, texture, material and relationship to the rest of the building and the surrounding area and meets the Ann Arbor Historic District Design Guidelines, in particular the guidelines for residential decks and patios, and the Secretary of the Interior's Standards for Rehabilitation and Guidelines for Rehabilitating Historic Buildings, in particular standards 9 and 10 and the guidelines for district or neighborhood setting.
