GLASER REZONING
(3122 GEDDES AVENUE)

AN ORDINANCE TO AMEND THE ZONING MAP BEING A PART OF CHAPTER 55 OF TITLE V OF THE CODE OF THE CITY OF ANN ARBOR.

The City of Ann Arbor ordains:

Section 1. THE ZONING MAP, which, by Section 5:4 of Chapter 55 of Title V of the Code of the City of Ann Arbor is made a part of said Chapter 55, shall be so amended as to designate the zoning classification of property described as follows:

Beginning at a monument in the north line of Section 34, Town 2 South, Range 6 East, Meridian of Michigan, 903.3 feet west of the northeast corner of said section; thence continuing west along the north line of the section 118.55 feet; thence deflecting 96°42' to the left, southerly 170.35 feet; thence deflecting 87°33'40" to the left, easterly 105.24 feet; thence deflecting 87°56'40" to the left, northerly along the line of occupation 161.49 feet to the place of beginning, being a part of the northeast quarter of Section 34, Ann Arbor Township, Washtenaw County, Michigan, in the City of Ann Arbor, Washtenaw County, Michigan as R1A (Single-Family Dwelling District).

Section 2. This ordinance shall take effect and be in force on and after ten days from legal publication.
