Whereas, New Life Church of Ann Arbor is the owner of property commonly known as 1541 Washtenaw Avenue, described at Liber 4545, Page 952 of Deeds, Washtenaw County Records; and

Whereas, New Life Church of Ann Arbor has signed a grant of easement for water mains and appurtenances, described as:

That portion of the following described property that lies within Lot 18, Assessor's Plat No. 18, in the City of Ann Arbor, Washtenaw County, Michigan, according to the Plat thereof as recorded in Liber 9 of Plats, Page 2, Washtenaw County Records: Beginning at the SW Corner of Lot 21 "Assessor's Plat No. 18, a part of Sections 28 and 33, T2S, R6E, City of Ann Arbor, Washtenaw County, Michigan as recorded in Liber 9 of Plats, Page 2, Washtenaw County Records; thence N47° 08' 30" E 362.98 feet along the line common to Lots 19 and 21 of said "Assessor's Plat No. 18" to the SE Corner of Lot 19; thence N00° 32' 05" W 42.61 feet; thence N89° 27' 55" E 40.00 feet; thence S00° 32' 05" E 33.24 feet; thence S47° 08' 30" W 17.82 feet; thence S42° 51' 30" E 10.00 feet; thence S47° 08' 30" W 40.00 feet; thence N42° 51' 30" W 10.00 feet; thence S47° 08' 30" W 109.49 feet; thence N42° 51' 30" W 2.49 feet; thence S47° 08' 30" W 9.65 feet; thence S42° 51' 30" E 2.49 feet; thence S47° 08' 30" W 11.99 feet; thence S15° 16' 14"

E 24.97 feet; thence S42° 51' 30" E 17.86 feet; thence S47° 08' 30" W 40.00 feet; thence N42° 51' 30" W 20.00 feet; thence S47° 08' 30" W 158.58 feet to a point on the Northeasterly right-of-way line of Washtenaw Avenue; thence N42° 32' 00" W 40.00 feet along said right-of-way to the Point of Beginning. Being a part of Lots 18 and 21 of said "Assessor's Plat No. 18" and containing 14,411 square feet or land, more or less.
