Resolution Authorizing Summary Publication of Ordinance ORD-08-06 - Amendment to Chapter 55, Rezoning of 81 Ann Arbor Township Properties from TWP (Township District) to R1A, R1B, R1C and R1D (Single-Family Dwelling District)

The City Charter contains provisions to allow summary publications of ordinances that are in excess of 500 words in length. RESOLVED, That the publication of Ordinance ORD-08-06 shall be by the following summary:
